**ORDINANCE OF THE BOROUGH OF HOPATCONG, COUNTY OF SUSSEX,  
STATE OF NEW JERSEY TO REPLACE PORTIONS OF CHAPTER 43 TO SET  
2011 SALARIES**

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Hopatcong, in the County of Sussex, New Jersey as follows:

Section : 1

The Code of the Borough of Hopatcong shall be modified to replace Section 43-9 in its entirety:

**43-9. Communication Operator Salaries.**

- A. The annual compensation schedule for full time communications operators of the Borough of Hopatcong shall be and is hereby fixed as follows for any employee who held employment with the Borough on or before January 1, 2009:

Senior Operator	\$60,216.00	\$62,022.00

- B. Annual compensation schedule for full time communications operator hired after January 1, 2009;

Starting salary:	\$25,000.00
Step 1	\$31,000.00
Step 2	\$33,526.00
Step 3	\$36,258.00
Step 4	\$39,213.00
Maximum	\$44,428.00

- C. All communications Operators will receive the step movement on their full-time anniversary date until they reach maximum grade.

- D. Compensation for part-time Communications Operators shall be set by the Governing Body via resolution at the time of hiring between the following ranges based upon experience.

Minimum \$10.00 per hour                      Maximum: 27.75 Per hour

No part time employee shall ever be scheduled in excess of 40 hours per work week and accumulate overtime without a written justification to the Chief Financial Officer.

- E. Hourly compensation for Part- Time Telecommunication with PTC: \$30.75.

Section 2. Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 3. Repealer. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 4. Effective Date. This Ordinance shall take effect upon final passage and publication as provided by law. 2011 Salaries shall be retroactive to January 1, 2011.
