MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY SEPTEMBER 2, 2015 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

ROLL CALL: The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Petillo.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

PRESENTATIONS:

Lake Hopatcong Foundation – Lake Loop Discussion

At this time Becky Rubenstein from the Lake Hopatcong Foundation discussed with the Council the activities that are going to take place on October 11, 2015 at the State Park. There are going to be bike routes, adventure trail runs and a paddle course.

COMMITTEE REPORTS:

<u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the market is running wonderfully and that the Dog Days event was very well attended. She stated that Space Farms is scheduled for September 13th to do an animal handling demonstration and that on the 20th there will be a "Fall into the Market" Harvest Day. There will be a boat show provided by Katz Marina and many of our community groups will be participating, such as the Community Garden, the Pound Project, The Lake Hopatcong Foundation, and the United States Coast Guard.

Councilwoman Galate also reported that the Senior group meets tomorrow and that they have a trip planned to Canada. She stated that the Business League is preparing for the annual Halloween parade.

Councilwoman Galate stated that she attended a police meeting and that the Chief has offered "ride-alongs" for the Governing Body members. They will be able to ride with one of the officers and sit in dispatch. He also offered tours through the department so that the Council can see what goes on in the department on a daily basis. She encouraged them to take the Chief up on his offer.

Councilman Francis stated that there is an ordinance on for introduction this evening amending the deer management code to "Wildlife Management" and also a resolution on for consideration to allow hunting in the Natural Area preserve. Both guns and bow hunting will be allowed. He stated that State representatives were very helpful in drafting the amending ordinance and that they are using the Borough as an example of good hunting practices.

Councilman Schindelar stated that there was a meeting this morning with the DEP regarding the Water Management plan as it relates to Lake Hopatcong. He stated they were going to address such things as water flow and the water levels. He stated that he will get more information and report back to the Council.

Mayor Petillo stated that she didn't think that the DEP was going to change the plan that they have been working on and have in place.

Councilman Young reported that the Recreation Commission held their last "Movie in the Park" event where they showed the Lego Movie. They also held an "Ice Cream Social". Both events were very well attended. At their meeting they started to already discuss next year's events as well as the upcoming Halloween parade and costume contest.

Councilman Young also stated that the skate park has been closed for repairs and they are hoping that the DPW will be able to do the work in house. The only vendor who has the panels is in Oregon and they are very expensive to ship.

Councilman Young reported that the Warriors will be holding their pep rally on September 11th at 6:30. It is a fun event where all of the kids have a great time. And he reminded everyone to drive safer as school opens tomorrow.

Councilman Schindelar stated that he hopes that we get the skate park repaired quickly because of lot of kids are now using the tables at the senior center to skateboard on.

Councilman Bunce stated that we are on track with getting the salt shed constructed. He also reported that the DPW is already starting to get all of the equipment ready for winter. He reminded everyone that the Annual Sussex County Firemen's Parade will be held on October 3rd and that information can be found on the Borough website as well as the Fire Department site. Councilman Bunce also reported that the Senior Spaghetti Dinner will be held on October 25th at St. Jude's.

Councilman Bunce stated that Crimestoppers will be holding their 5K and 12K run on September 18th and encouraged everyone to participate in this fun event.

Councilman Bunce happily reported that Moody's has raised the Boroughs bond rating to AA. The report stated that Hopatcong is in a very strong financial position due to our conservative budgeting and all of our hard work.

Mayor Petillo reminded everyone that we will be holding a 9/11 service next Friday at 10:00 am to commemorate the 14th anniversary of the terror attacks on our country.

PUBLIC COMMENT: <u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning items on the agenda for which no public discussion is provided. (Comments limited to 5 minutes).

Mara Modes asked about the request from 18 Temple Trail to construct pillars in the right of way. She asked what "pillars" are.

Mayor Petillo stated that they are columns to put lights on as their driveway is very dark.

After giving all persons present an opportunity to address the Governing Body, Councilman Bunce made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Young. All were in favor.

Councilman Bunce made a motion to approve the meeting minutes of the Regular Meeting held on August 5, 2015 and the Special Meeting held on August 19, 2015. Seconded by Councilman Young. All were in favor.

ADMINISTRATOR'S REPORT:

At this time Robert Elia, Borough Administrator, presented his report for the meeting of September 2, 2015.

Mr. Elia stated that the improved bond rating will allow the Borough to obtain lower interest rates on not only new bonds, but on bonds that we currently have and roll over. He also stated that last year Standard and Poors improved our bond rating as well.

Mr. Elia informed the Council and the public that the Borough was fortunate enough this year to receive another Housing Rehabilitation Grant award in the amount of \$25,000. This is the third year that we have received the grant and it will help many residents make much needed repairs to their homes. He stated that last year we initially received

\$25,000 but that as time went on the award was increased so that we were able to help more homeowners.

Mr. Elia also reported that as everyone knows, Kelleyanne McGann, our CFO for 20 years retired last week. We have placed an ad to hire a new CFO and we have gotten resumes from a couple of qualified applicants. Hopefully, by the next meeting of the Mayor and Council, there will be a recommendation to hire a qualified applicant.

Mr. Elia also stated that there is a resolution on this evening for consideration in support of "Idle Free Zones" in the Borough. If the town passes this resolution it will go towards points needed to obtain the "Bronze" designation in the Sustainable Jersey program. We started the process back in 2009 and programs such as the Community Garden and the Farmer's Market have given us points towards reaching that designation.

<u>Discussion – Construction/Replacement in the Municipal Right of Way</u>

At this time the Governing Body discussed construction/replacements in the municipal right-of-way. They agreed that each one needs to be taken on a case by case basis and that if necessary some of them need to go back before the Land Use Board. The procedures will be reviewed and they directed the Administrator to have a discussion with the Zoning Officer as to the process.

Appointment of Alternate for the Environmental Commission

Councilman Young made a motion to approve the appointment of Jen Barone as an alternate for the Environmental Commission. Seconded by Councilman Bunce. All were in favor.

At this time, Mayor Petillo administered the oath to Jen Barone and welcomed her aboard. She also thanked her for all of her dedication to the Borough and for all of her hard work on the Community Garden.

<u>Discussion – Free Little Library</u>

At this time Mayor Petillo asked the Council if they would be in favor of a volunteer constructing a free little library here at Borough Hall. The concept of the library is that she would construct a small wooden "little library" that she will fill with books. A child could come and borrow a book as long as they place one in the box in return.

After discussion it was agreed that she could construct the library on the back corner of Borough Hall and not in the 9/11 memorial. That area should be left as a monument to first responders and victims of the 9/11 attacks.

Sign Ordinance Discussion

Councilman Young addressed his request from the last meeting to amend the sign ordinance to allow non-profits to be able to advertise their events with larger signs on residential properties. He stated that currently they can only advertise on commercial properties. After discussion, the Council directed Mr. Ursin to amend the sign ordinance to allow non-profits to erect larger signs to advertise their events on residential properties on Sparta-Stanhope Road as well as on commercial properties in the rest of the Borough.

PUBLIC COMMENT:

<u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning the good and welfare of the Borough. (Comments limited to 5 minutes).

Mara Modes addressed the ongoing construction on River Styx Road and suggested that the police are not directing traffic properly. She said that they should have flags and should not be waiving water bottles.

Councilman Bunce stated that he took offense to her comments and that our police officers are doing a great job with traffic control in the area. The officers are standing in the heat directing the traffic and are very noticeable to motorists.

Ms. Modes asked who will be maintaining the parking lot by Hudson Maxim school and the Mayor stated that the Borough will be, unless the school wishes to contact us to make other arrangements.

Ms. Modes stated that she is very upset by Slomins soliciting in her neighborhood and that they scared a young girl to the point that the police had to be called. She asked if the Borough could prohibit them from peddling.

Mayor Petillo stated that she is aware of the situation and that Slomins is a licensed peddler in the Borough and that we just can't forbid them from doing so – it goes against their constitutional rights. She stated that if anyone has that type of issue with any peddler that they should call the police. That girl did the right thing.

Ms. Modes also stated that she has complaints about the gas station across from Borough Hall. She stated that they fill the tank up so that it overflows and they won't give change.

Councilman Bunce stated that is not an issue for this Governing Body and that she should call the State if she has complaints.

After giving all persons present an opportunity to address the Governing Body, Councilman Bunce made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilwoman Galate. All were in favor.
