CALL TO ORDER: Announce Quorum

ADOPTION OF 2018 MUNICIPAL BUDGET

Public Hearing on 2018 Budget

At this time, Paul Lerch, Borough Auditor, presented the 2018 budget to the Council. A copy of the presentation is attached.

At this time Mayor Francis opened the meeting to the public for any questions or concerns that they may have regarding the 2018 Budget.

David Harris asked about the anticipated surplus of 5.6 million dollars.

Mara Modes asked about the emergency appropriation and the CFO, Lorraine Rossetti, responded that it was for the phone system that wasn't installed yet. We had to put more money into the budget to cover the cost that we had anticipated saving by having the new system installed.

Councilman Padula thanked Lorraine Rossetti and Paul Lerch for all of their hard work on the budget. He stated that in 2010 the Borough had 1 million in surplus and now we have 5.6 million. He stated that he would like to formulate a plan so that surplus doesn't get away from us. There needs to be a discussion on how to handle surplus in the future and fiscal responsibility. He stated that if the trend continues, we will at some point have too much cash on hand. He also stated that it wouldn't be wise to use all of our surplus and be caught without any money in case of an emergency. He would like to get started on formulating a plan for the 2019 budget.

Councilman Bunce stated that he would like to ask Paul Lerch for guidance on how other towns handle their surplus.

Paul Lerch stated that he will present the Council with 5 or 6 plans.

Councilman Hoferkamp stated that there should be a cap on taking loans.

Councilman Padula stated that paying down debt is another possibility for the surplus. He also stated that we should have a cash plan where we look at not only the collection side but the spending side.

Paul Lerch stated that the plan could be fluid and it can be changed with the circumstances.

Mayor Francis said that we can set a range, perhaps a percentage, rather than dollar amount.

Councilman Young stated that we should make some projections and formulate a plan in case things happen.

Mayor Francis stated that he feels that it is a very conservative, well thought out budget.
