# MINUTES OF THE MAYOR AND COUNCIL MEETING,

## SEPTEMBER 3, 2014 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT: Council President Young** stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Council President Young noted fire exits)

<u>Council President Young</u> invited all present to salute the flag and to remain standing for a moment of silence.

Councilwoman Galate reported that the Senior group meets tomorrow and that the Farmer's Market is going wonderfully this year.

Councilman Bunce stated that the Senior Picnic that is sponsored by the Council and the Knights of Columbus will be held on October 26<sup>th</sup> this year and he encouraged everyone to come out to enjoy the great food and entertainment.

**PUBLIC COMMENT:** Council President Young requested a motion to open the meeting to the public for any questions or comments concerning items on the agenda for which no public discussion is provided. (Comments limited to 5 minutes).

Robin Calandriello, 116 Hudson, asked why the Borough was approving the liquor license for the River Styx Grill if the owner is in jail.

Mr. Ursin responded that it is a matter of business that needs to be taken care of so that the license can be transferred to someone else. If the town doesn't renew the license then it would jeopardize the sale of the River Styx Grill to the prospective buyers.

Mr. David Harris, 128 Dupont Avenue, addressed the Council regarding the paving of Dupont Avenue.

Councilman Bunce stated that the drainage work on that road has been completed and that the town is just waiting for the paving company to come and finish the job.

Mr. Harris also asked if Dale Sloat is working and Mr. Ursin responded that he, the ACO, is currently on the payroll for the Borough.

Barbara Loring, Ithanell Road, asked whether or not all dead animals found on the roadways are tested for rabies. The Council responded that health regulations are followed but that it would be very costly to test every animal that is found dead.

## **ADMINISTRATOR'S REPORT:**

At this time Robert Elia, Borough Administrator, presented his report for the meeting of September 3, 2014. He stated that the Borough is fortunate to once again be the recipient of a USDA housing rehabilitation grant. We were one of only two municipalities in the State to receive one. This year we received \$10,232 which will be used to help one or perhaps two residents in need of the program. So far, in the last two years, 18 residents have taken advantage of the income-based program.

## **PUBLIC COMMENT:**

Mr. Harris also asked if there was any resolution to the resident's problem about the field and the baseballs being hit into his yard.

The resident has requested that the fields actually be locked. Council President Young stated that the fields are maintained by the Borough and funded by the tax payers of the municipality. They are researching the request and considering rule changes for the fields.

Amy Chamer, 127 Blackfoot Trail, stated that she would like the Council to look into the structure at the bus stop up in Northwood. She stated that she spoke to the DPW and was told that the structure is not owned by the Borough. The Administrator stated that he would look into it and that the choice of bus stops is made by the schools and that perhaps she should contact them.

Barbara Loring, Ithanell Road, stated that she is still concerned about speeding on Ithanell Road. A while back the residents had asked for speed bumps and they were told that the town would not construct them. She asked if rumble strips could be a possibility. She also asked that there be more of a police presence on the street.

Councilman Bunce stated that they would also be a problem for the snow plows as the plow would rip them up.

The Administrator, Robert Elia, stated that he would discuss the situation with the Chief of Police.
