#### Basketball:

Planning as started with Chairperson Sutton reaching out to other towns. Waiting to hear back from 2 towns. Will have a meeting with towns to go over rules, scheduling. Will be reaching out to coaches to see who is coming back. Online registration opens September 23, 2024 and all in-person registration is at borough hall. Clinic–K, 1st and 2nd grades. League–3rd, 4th, 5th, 6th, 7th, 8th. Hope to start a month earlier with practice in November and clinic and games to begin in January and end in March. Met with the Superintendent and are able to use the HHS gym on Saturdays. Will not be using Durban Ave or the Middle School, saving money. Will continue to use Tulsa Trail and middle school for practice. HHS has a better, bigger gym and be separated into 3 practice sessions at the same time. Joe Falconi is helping with scheduling but need someone to run the scheduling program. Frelinghuysen holds the program, so maybe another town can run it. Facility requests have not been submitted because they are working on the system. Wrestling will be using the auxiliary gym. There are 2 Saturdays basketball will not be able to use main gym because of wrestling tournaments. Need coaches' bag to include pinny, first aid kit, dry erase board, cones, ice pages, scorebooks.

Door monitors will be discussed before the season starts. Need a facility request for tables and chairs. Looking into what other towns are doing regarding the Ref fees. All volunteers need to be background checked. Rutgers has a Certified program for the coaches, insured up to 1 million dollars. Coaches might be able to do it here. Commissioner Gravatt requested that we get "real" game ball "Wilson Evolution Ball" and maybe reversible jerseys.

Can keep pricing same as long as we have same enrollment as last year; 125 kids (\$100—3<sup>rd</sup>-8<sup>th</sup>; \$50—Clinic)
