OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

INTRODUCTION OF 2016 MUNICIPAL BUDGET:

At this time, Mayor Petillo introduced Paul Ralph Picone, the Borough auditors who presented to the Governing Body and the public the 2016 Municipal budget. A copy of the budget presentation is attached. The proposed budget will increase \$22.00 for an average residential home valued at \$214,256. The breakdown is as follows: 28 cents goes to municipal budget, 54 cents goes to the school and 18 cents goes to the County. The County and School amounts are approximate numbers because they haven't introduced their budgets as of yet. They are based on a 2% increase.

BUDGET HEARING: APRIL 6, 2016 OR SOON THEREAFTER

COMMITTEE REPORTS: <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate stated that the senior meetings are going well and very well attended. She also reported that the Farmers Market planning is underway and that the committee is reaching out to vendors.

Councilman Francis reported on last night's Land Use meeting. He stated that there were 4 routine applications on the agenda for residents doing home improvements.

Councilman Young reported that the Environmental Commission is working on obtaining grants for trails. He stated that they have scheduled the tree give-away for April 23rd and are planning their Arbor Day celebrations and the Lake Hopatcong Block Party. Councilman Young also stated that the Recreation Commission has scheduled the Easter Egg Hunt for March 20th with a rain-date of April 10th. He stated that the Street Hockey Program will be starting soon as well as all of the spring sports.

Councilman Young stated that the Range Committee has begun their research but that they have nothing to report at this time.

Mayor Petillo stated that the Lake Hopatcong Foundation has received a \$20,000 grant to be used on trails in Hopatcong Borough.

Councilman Bunce stated that we held a bid opening for the DPW Wash Bay and that all of the bids we probably be rejected because the amounts were too high. He also stated that the Ambulance Squad is beginning the process for their building expansion. He reported that the Armed Forces Relief will be holding their spring event on May 22, 2016.

Councilman Padula reported that the newly formed Redevelopment Committee met in February and that they are working on their charter. The next meeting will be on April 5, 2016.

PUBLIC COMMENT: <u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning items on the agenda for which no public discussion is provided. (Comments limited to 5 minutes).

David Harris asked if the Borough will be saving money by the refunding of the bonds and Mr. Elia reported that we will be saving approximated 2.6 million over the next 15 years. He stated that this was the first opportunity for the Borough to refund these bonds.

After giving all persons present an opportunity to address the Governing Body, councilman Bunce made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Young. All were in favor.

Mr. Elia reported that there is a resolution on this evening to enter into an agreement with Max Span Reality Group to market Borough owned properties. They will get a 10% commission but the buyer will pay it.

David Hughes addressed the Governing Body regarding Public Defender fees and wanted to know why the town paid them \$400 on this bill list.

Mr. Elia stated that the town pays a part and the applicant pays a portion. The courts make the rules when it comes to public defenders.

Elaine Vigliotti, 6 Maple Place, once again addressed the Governing Body regarding the proposal to put a firing range near her home. She stated that there was a gate installed on the roadway going in to the property which makes it difficult for people to get to the trails. She also stated that she has found other properties in town that may be more suitable than that location. She wanted to know when the committee will be giving a report.

Councilman Bunce stated that many of her questions were answered by the Mayor at the last meeting.

Councilman Francis stated that the committee will be gathering information and that after their review they will make a recommendation to the Council.

Alice Stolarz stated that even though this Governing Body may make a decision regarding the firing range that politicians change.

Mara Modes asked about the locked gate and Mayor Petillo stated that it needs to be kept locked because people go up there and dump illegally.

Mrs. Grove also addressed the range and wanted to know why all of the towns and the County don't build a range that can be used by all of the police departments. Then it could be used in shared service agreements.
