# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY MAY 20, 2015 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

**ROLL CALL:** The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Petillo.

**MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE:** <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

#### **AUCTION OF MUNICIPAL PROPERTY: (All conforming properties)**

#### **COMMITTEE REPORTS:**

Councilwoman Galate reported that the Seniors group is growing and that they are well represented in all age groups. She stated that the Farmer's Market is coming along and they already have several repeat vendors and demonstrations and music lined up. She also reported that the Sussex County League of Municipalities will hold their June meeting at the Skylands baseball stadium

Councilman Francis stated that the Farmer's Market is growing and that they will have many presentations this year including a Civil War reenactment, DEP presentation regarding bears and the Lake Hopatcong Foundation who will do a presentation on boating safety.

Councilman Young reported that the Recreation Commission will be holding an Ice Cream Social on August 22, 2015. The Commission held a movie night at the high school and it was very well attended. Councilman Young also reported that the Environmental Commission participated in the Hopatcong Block Party and the First

Annual Sussex County Day. He also stated that a resident who is a beekeeper is interested in doing a presentation and perhaps will have an open hive for everyone to view. The Commission had over a hundred people participated in the tree giveaway and that they are in the process of discussing Hopatcong Days. They will not be holding a poster contest this year and didn't have their annual hike on Earth Day. They may have a hike in June to celebrate National Trails Day.

Councilman Bunce reported that there are resolutions on tonight to award contracts to vendors who will complete the paving for our two DOT grants that the Borough was awarded. He stated that the DPW Committee is meeting tomorrow and that the paving in Wildwood Shores is complete.

Mayor Petillo stated reminded everyone that the Memorial Day parade is this Saturday.

**PUBLIC COMMENT:** <u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning items on the agenda for which no public discussion is provided. (Comments limited to 5 minutes).

Cliff Lundin addressed the Council regarding the trail easement that he would like incorporated into the ordinance that is on the agenda tonight to auction off 501 Lakeside Blvd. He stated that he had gotten an email from Bob Elia stating that the Council was would not entertain giving the easement prior to the auction.

Mr. Ursin stated that he is familiar with the property and that the easement would have little or no effect on the price of the property.

Councilman Bunce and Councilwoman Galate both stated that they were not made aware of the issue by Mr. Elia.

Mr. Ursin stated that the ordinance could be introduced now with that caveat and that he would provide the Governing Body a map of the property with the easement.

After discussion, the Governing Body agreed to introduce the ordinance with the easement language included for adoption.

Dave Berchak, 67 Kynor Avenue, addressed the Council regarding residents leaving their garbage out in plastic bags rather than in covered containers. The animals get into the bags and make a mess.

Mayor Petillo stated that it is part of the ordinance that garbage has to be put out in covered containers. She stated that we will put out a reminder on Facebook and the website.

Gwen Switzer, 129 Camp Trail, once again addressed the Council regarding the condition of her street. She stated that at the last meeting she told the Council that her street was in such bad condition that it is dangerous. She and her children have all fallen on the gravel. She wanted to know if Camp Trail was on the list this year to be paved.

Mayor Petillo apologized to Ms. Switzer for not getting back to her. She stated that she and the DPW Superintendent both went out to look at the road and that it is in bad condition. Unfortunately, however, there are many other roads in town that are in worse condition and are a priority for the Borough. She stated that the bad winters have taken a toll on many of our roads and that we don't have enough money to fix them all this year. We have received grants for paving but the money is designated for certain roadways.

Ms. Switzer asked if she could have a list of the roadways that are being considered for paying this year and the Mayor responded that she could OPRA the list. Ms. Switzer asked if the street sweeper could be sent down the street. Mayor Petillo stated that she believes that if went down that street already but that she would instruct the DPW to sweep it again.

After giving all persons present an opportunity to address the Governing Body, Councilman Young made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Bunce. All were in favor.
