Mayor Francis stated that it will be in the plaza next to RiteAid. He stated that the owner will be renovating it at no cost to the Borough. Everything will be new. The owner wants to give back to the community.

Lynn Owens, wants to know when the fire lane at the end of Squaw will be taken care of.

Mr. Tappan stated that we are hoping to take care of all of them once a year.

David Harris asked if the Hopatcong Pound Foundation is related to the Borough Pound because he was in a store and there was a can soliciting donations for them.

Mr. Ursin stated that they are a non-profit, not associated with the Borough. He told Mr. Harris that he can contact the attorney general if he feels that it is not a legitimate organization.

Mayor Francis stated that they are not a part of the Borough and not under our purview.

Mr. Harris asked what the function of the new community center will be.

Mayor Francis stated that groups such as Project Self Sufficiency, CLEAR and other non-profit groups will be able to use it to provide services to the residents. That way they will not have to go up to Newton to seed assistance. We will be getting it rent free and we will only be waving the \$629 in taxes associated with that unit.

After giving all persons present an opportunity to address the Governing Body, Councilman Young made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Hoferkamp. All were in favor.
