MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY JUNE 7, 2017

OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Francis</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

ROLL CALL: The Clerk called the role and the following members were present: Councilman Bunce, Councilwoman Galate, Councilman Hoferkamp, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Francis

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Francis</u> invited all present to salute the flag and to remain standing for a moment of silence.

COMMITTEE REPORTS: <u>Mayor Francis</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the Hudson Hike was very successful -83 seniors participated and there was a total of 1382 participants that helped raise \$50,164. There were also 1070 bonuses given for a grand total of \$75,000 that Hudson Farm will donate to several local organizations. She stated that this year the route was changed to a 6 mile hike, which may have been too strenuous for some participants. Next year they may do a shorter hike as well as the longer 6 mile hike.

Councilwoman Galate also reported that the Memorial Day parade was very successful and that it was a beautiful day. She reported that the Seniors Inc. Installation Ceremony will be held on June 21st and the senior picnic will be held on the 24th. She announced that the Farmers Market will kick off on June 18th and that many special events are already scheduled – June 25th Blessing of the Bikes, July 16th Boat Show and July 30th EMS Day.

Councilman Hoferkamp reported that the Environmental Commission gave away the rest of the trees at the Hudson Farm Hike.

Councilman Schindelar stated that the Memorial Day Parade was a success and that the attended the MSA meeting. He also stated that he and the Mayor met with Senator Bucco to discuss the MOA sent to the 4 towns around the lake.

Councilman Young reported that the Environmental Commission has been discussing the proposed rain garden and Hopatcong Days. He stated that the Hudson Hike participants were an average age of 36 and he also stated that the trail was very aggressive. Councilman Young reported that the Municipal Alliance has scheduled a movie night on June 23 at the Hilltop Field.

Councilman Bunce stated that there are two capital ordinances on for consideration this evening. He also reported that the Ambulance Squad has requested their funding for the 2016 and the 2017 budget years as they haven't received it yet. He thanked the Squad for all of their hard work and dedication to the residents of the Borough. Taxpayer dollars really help the squad and make a huge difference.

Councilman Bunce also reported that the Armed Forces Relief Event and the Crimestoppers Sheriff's Reception were both a huge success.

Councilman Padula stated that the Redevelopment Committee met with the owners of the music studio next to Pavinci and that it was a very successful meeting. Councilman Padula hopes that the Redevelopment Plan will be on for consideration by the Council at the next meeting.

Mayor Francis stated that the town has applied for a marketing grant for the Redevelopment area and that he created a PowerPoint of the area and it is on our website.

Councilman Bunce thanked Cathy Millian, the Recreation Coordinator, for creating the Hopatcong Happenings publication. He stated that it has wonderful information for the residents of the events that are going on in the Borough.

Mayor Francis stated that he and Councilman Hoferkamp have been meeting with the judge to initiate a Community Service program.
