MINUTES OF THE

OPEN PUBLIC MEETING 7PM

CALL TO ORDER: The Recreation Commission Chairperson called the meeting to order at 7:00 PM.

OPEN PUBLIC MEETINGS ACT STATEMENT: This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald and posted on the bulletin board maintained in the Municipal Building for public announcements.

OLD BUSINESS:

Cross Country

Chairperson Sutton stated that there are 10 players, including one player from Jefferson. In need of new uniform. Suggestion to charge out-of-town players \$100. Jefferson and Sparta Cross Country have around 50 participants. There is \$900 in the trust. Superintendent Vasile said there should be \$1,000; \$900 electronically and \$100 in person. The only expense for cross country is payable to the League. Commissioner DiNapoli asked if we needed to pay additional insurance with the answer being no, the coverage from Field and Track is still in effect.

Commissioner Barella made a motion, Commissioner DiNapoli seconded the motion. All in favor.

The game was entertaining and we filled 3 rows (14 seats per row).

Concert in the Park

Superintendent Vasile was concerned about the low turnout, 25 people at most. Chairperson Sutton suggested that it be moved to a weekend because weekdays are tough for people to attend. Councilwoman Johnson suggested a Friday night. Superintendent Vasile also said he had other bands to and would send a link for review. Chairperson Sutton suggested bringing back the concert in the park and volleyball, the derby and Sunday softball all weekend with Hopatcong Days. Could also bring in Irish Dancing school, karate school.

Food Truck Festival

PBA cancelled, reason unknown.

Field Request

Kick Soccer requested use of Vet's Field for the months of July and August at a cost \$125 per month, paid upfront. However, due to low enrollment, Kick Soccer only used the field for July. Therefore, will need to reimburse them \$125 for nonuse in August.

MOTION TO APPROVE \$125.00 FOR REIMBURSEMENT TO "KICK SOCCER":

Commissioner Vinkman made a motion, Commissioner Turkington seconded the motion. All in favor.

New Jersey Devils

Superintendent Vasile suggest 3 dates: January 17, March 3, March 29. March 3rd was chosen since the Hopatcong Marching Band will be playing that day. Cost is \$50 per person. Supertindent Vasile suggested to market it as a Christmas/Hanukkah gift.

Trust

BA Snow, Superintendent Vasile and Chairperson Sutton have been working together to fix discrepancies regarding the trust account. BA Snow says that the senior money needs to be put back into the trust and take the senior nutrition program out of trust. Both the BA and CFO are working on issues to fix. There should \$13,000 back into the trust once resolved.

MOTION TO APPROVE \$355.92 FOR BJ RECEIPT FOR HOPATCONG DAYS:

Commissioner Barella made a motion, Commissioner DiNapoli seconded the motion. All in favor.

MOTION TO APPROVE \$108 FOR TRACK AND FIELD FINGERPRINTING FOR 4 COACHES:

Commissioner Vinkman made a motion, Commissioner Turkington seconded the motion. Darrin DiNapoli, Cheryl Ostman, Wendy Sutton, Jacking Turkington and Ulla Vinkman were in favor. Dave Barrella abstained, stating it is a town requirement and not going to ask volunteers to pay, but doesn't agree that the Recreation Commission needs to pay it, the town should.

NEW BUSINESS

Basketball

Chairperson Sutton suggested increasing the registration for the league from \$100 to \$125 and to leave clinic at \$50 based on the same number of players (110), therefore having an additional \$2,950 to help cover increasing insurance costs and gym usages fees. Commissioner Turkington suggested that clinic be increased to \$55 and league to \$120. Chairperson Sutton had concerns increasing the clinic and didn't want to lose players over \$5 and agreed to just increasing the league to \$120 for an

additional \$2,200 to help cover costs. Referee will stay at \$50 and Scorekeepers will stay at \$15 per game.

MOTION TO APPROVE FEE INCREASE FOR LEAGUE BASKETALL TO \$120 AND CLINIC BASKETBALL TO STAY AT \$50:

Commissioner DiNapoli made a motion, Commissioner Vinkman seconded the motion. All in favor.

MOTION TO APPROVE PAY PER GAME; REFEREE \$50, SCOREKEEPER \$15 AND ASSIGNER \$5:
