Introduction Ordinance #29-2015 - Sign Ordinance

Currently hunting can take place in the Natural Area Preserve.

Mara Modes asked if there is a permitting process and the Clerk, Catherine Schultz, explained that they have to get a permit from the Borough in order to hunt on municipal property. They have to have a valid NJ hunting license.

PUBLIC COMMENT:

<u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning the good and welfare of the Borough. (Comments limited to 5 minutes).

David Harris thanked the Governing Body for restriping some of the Borough roadways.

Mayor Petillo responded that the Borough is put on a list and that we have to wait our turn to get the restriping done.

Mara Modes addressed the Council regarding a statement that she made the previous evening regarding the new development that came before the Land Use Board. She stated that she didn't believe that the clean-up process and the remediation process were taking place and that they should have been made to hire an LSRP to remediate the problem as a condition of their approval.

Councilman Francis replied that it is not right of Ms. Modes to give the illusion that nothing has taken place with regards to remediation. He stated that she was told at the Board meeting last night that based on our current ordinances it did not meet the criteria. He stated however, that there has been an active remediation process going on there for years.

Mayor Petillo stated that the Borough is very aware of the remediation process at that location. For 20 years there has been some type of remediation and more recently an LSRP was hired and it is constantly monitored by the DEP. She told Ms. Modes that if she would like any records regarding the remediation process that she could contact the Sussex County Board of Health.

Councilman Bunce asked if Mayor Petillo would let Councilwoman Galate know that "Crime Stoppers" is willing to come and speak to the seniors about issues that are relevant to their safety.

Councilman Schindelar asked if boats are allowed to be parked so close to the road, in the municipal right of way. Mayor Petillo responded that he should speak to the Zoning Officer if he has any concerns regarding that. They should not be parked in the municipal right of way.

After giving all persons present an opportunity to address the Governing Body, Councilman Bunce made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Young. All were in favor.
