# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY MAY 18, 2016 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

**ROLL CALL:** The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Petillo.

**MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE:** <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

### PRESENTATIONS:

At this time, Mayor Petillo presented a proclamation to the Lake Hopatcong Sail & Power Squadron as they celebrate their 50<sup>th</sup> Anniversary.

Councilman Bunce made a motion to take a five minute recess. Seconded by Councilman Young. All were in favor.

Councilman Bunce made a motion to return to the regular order of business. Seconded by Councilman Schindelar. All were in favor.

Mayor Petillo informed the Council that the weed harvesting program was allocated \$155,000 and that it will begin on May 24<sup>th</sup> with three large machines. In June, they will add another machine and the harvesting will continue until the money runs out. She stated that the focus will be in the areas from the State Park to the River Styx area.

Mayor Petillo also reported that the High School graduation ceremony will be on June 14<sup>th</sup> at 5:45 and the Middle School ceremony will be on the 15<sup>th</sup> at the same time.

**COMMITTEE REPORTS:** <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate stated that the Seniors have decided for the time being to continue to meet at the Senior Center. She stated that they have added another trip this summer to Radio City Music Hall. Regarding the Farmer's Market she stated that so far we have 17 vendors signed up to participate.

Councilman Francis stated that he spoke to some of the vendors at the Block Party and that they might be interested in attending this year's market as well. He also reported, with regards to energy, that when the town needs to replace bulbs, we replace them with cost effect LED lights.

Councilman Francis stated that the Land Use Board will be holding a public hearing regarding the possibility of creating a Redevelopment Zone on River Styx.

Councilman Schindelar stated that the attended the Lake Hopatcong Block Party and that it was a huge success.

Councilman Young reported that the Environmental Commission received a small grant from ANJAC in the amount of \$800. They are going to use it for some signage on the trails. He also stated that the Recreation Commission held a movie night and that they are purchasing items for the summer program. The Commission is also going to be holding an Ice Cream Social in conjunction with a concert being run by the Municipal

Alliance in August. He stated that he has spoken to the DPW and was told that the panels will be put on the Skate Park once the weather warms up.

Councilman Young reported that the Hudson Farm Hike was a huge success and that 11 organizations benefited from their donation. This year they also held a "seniors" tour that was very well attended by 62 seniors.

Councilman Bunce stated that the Crime Stoppers dinner will be held next Thursday at the Farmstead and that the Armed Forces Relief Fund Dinner will be this Sunday at Pavinci. He also reported that the Memorial Day Parade will be held on the 27<sup>th</sup> at 10:00 am here at the Borough Hall.

Councilman Padula reported that the Redevelopment Committee will hold its next meeting on June 8<sup>th</sup> and that they will be discussing the report submitted by the Engineer and also the progress of the marketing grant.

Mayor Petillo thanked all of the churches that participated in the "Hunger Walk". They raised a lot of money that will be used to help residents who are in need.

**ADMINISTRATOR'S REPORT:** At this time Robert Elia, Borough Administrator, presented his report for the meeting of May 18, 2016.

At this time, Mayor Petillo discussed with the Council two projects that she would like them to consider approving. One would be in conjunction with a Girl Scout who is trying to obtain her Silver Award. She would like to construct a small playground at Jefferson Field for younger children. She thinks that she can raise \$5000.00 and the town would be responsible for the rest.

The other project Mayor Petillo would like the Council to consider is a pavilion next to the parking lot at the Borough Hall. It would accommodate two game tables on each end with room in the middle for bands, events, etc. The pavilion would cost \$10,000. She stated that the money for the playground and the two tables could be paid for from funds in the Recreation Trust. She believes that \$12,000 would be sufficient. She stated that the money for the pavilion could come from the money that PSE&G gave the Borough.

After discussion, the Council agreed to both projects and the funding.

Councilwoman Galate asked the Mayor to please also take a look at the area by Vet's Field. She stated that it would be a great place for another playground. Mayor Petillo stated that she thinks that is a great idea and that they will take a look at it.
