# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY JUNE 17, 2015 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Council President Galate</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Council</u> <u>President Galate</u> invited all present to salute the flag and to remain standing for a moment of silence.

### **AUCTION OF MUNICIPAL PROPERTY:**

Councilman Young made a motion to open the auctions. Seconded by Councilman Bunce, All were in favor.

Block 40402, Lot 7 – 3 Michigan Trail (Conforming – Minimum Bid \$11,700)

Council President Galate explained that normally we put up property for auction when we are approached by someone who is interested in purchasing it. Sometimes though, through the process they change their minds and don't follow through on the purchase.

Councilman Bunce reported that there was a Firemen's Parade meeting last week and that the plans are moving along. The parade will be here in Hopatcong on October 3, 2015

Councilman Young reported that the Environment Commission is planning a Hazardous Waste Day here in the Borough. At their meeting they reviewed their participation at the Lake Hopatcong Block Party and also at Sussex County Day. The Commission is setting up a Facebook page to advertise their events and accomplishments. One of their accomplishments was submitting the paperwork to Sustainable Jersey for the Bronze designation.

Councilman Young also reported that the Recreation Commission has 95 registrations for the full time summer recreation program. He anticipates that there will be even more campers registering before it begins. Ryan has done a wonderful job with the program which is self-sufficient. The movie in the park was cancelled last Friday due to potential of thunderstorms and has been rescheduled for this coming Friday.

Councilman Francis reported that the Farmers Market starts this Sunday and encouraged everyone to come out. This year we will have many demonstrations including a Civil War reenactment. Councilman Francis also reported that the Deer Management Task Force, with input from the State will be recommending to the Council shortly, areas in the Borough where hunting will be allowed.

Mr. Elia also stated that we received \$36,000 for a Clean Communities grant and that there is a resolution that needs to be adopted to put the money into the 2015 budget. He also congratulated the Environment Commission on their submittal to Sustainable NJ for the bronze level designation. They have held many events such as the Farmer's Market, the tree giveaway, vehicle inventory and energy saving programs. This will allow them to apply for grant monies.
