BOROUGH OF HOPATCONG ORDINANCE NO. 12-2025

ORDINANCE OF THE BOROUGH OF HOPATCONG, COUNTY OF SUSSEX, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING THE HOPATCONG BOROUGH CODE TO CREATE CHAPTER 85 ENTITLED "BUSINESS AND RESIDENTIAL RENTAL UNIT REGISTRATION"

WHEREAS, the State of New Jersey has enacted a new statute which requires business owners, rental unit owners, and owners of multifamily homes which is four or fewer units, one of which is owner-occupied, to maintain certain liability insurance policies and register certificates of insurance demonstrating compliance with such statute with the municipality; and

WHEREAS, said law provides that the municipality may, by ordinance, establish a reasonable administrative fee for the certificate of registration; and

WHEREAS, in an effort to recuperate some of the administrative costs, incidental to the registration of businesses and certain residential rental units, the Borough wishes to adopt the subject Ordinance and to establish a reasonable administrative fee for the subject certificate of registration, as permitted by law.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Hopatcong, County of Sussex, State of New Jersey that the Borough Code of the Borough of Hopatcong is amended and supplemented by creating Chapter 85 entitled "Business and Residential Unit Registration," as follows:

SECTION I:

Chapter 85. Business and Residential Unit Registration.

§ 85-1. Definitions.

The following words and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

BUSINESS — Any person or entity offering and/or engaged in buying, selling, storing, and/or transferring merchandise, goods, real property, personal property, moneys, services, and/or other items who do so for a fee, price, retainer, commission, percentage, and/or other means of compensation for the purpose, stated or otherwise, of realizing a profit or other gain.

CERTIFICATE OF INSURANCE — A proof of current liability insurance insuring against negligent acts and omissions for a particular property and premises issued by an insurance company and stating coverage for a particular property and premises.

OWNER — A person, entity, who owns, possesses, or has the right to control through any agency agreement any residential rental unit or units, or who owns or possesses a business which owns or possesses any residential rental unit or units.

RESIDENTIAL RENTAL UNIT — Any single-family residence, apartment, studio, condominium, and/or other dwelling designed to be occupied by one or more persons and rented, leased and/or otherwise offered for use by other than the owner for one or more nights in a calendar year.

§ 85-2. Annual Registration of Business and Residential Rental Unit.

All persons who own, possess, or control any business or residential rental unit or units located within the Borough of Hopatcong shall annually register each and every said business or residential unit or units with the Municipal Clerk of the Borough of Hopatcong in such form as may be required by the Borough of Hopatcong from time to time.

- A. All businesses or residential units shall be registered with the Municipal Clerk no later than January 30 of each calendar year.
- B. The annual fee for registering as a business or as a residential rental unit owner with the Borough of Hopatcong is \$200.00 per business or residential rental unit for the first year and \$100.00 for each subsequent year thereafter.
- C. A residential rental unit owner shall be required to register all residential units owned by that owner every year when registering as a residential unit owner with the Municipal Clerk.
- D. There shall be a late fee of \$25.00 for every registration which is submitted after January 30 of each calendar year.
- E. All residential rental units located in any residential setting which is regulated, registered, or otherwise subject to the jurisdiction of the New Jersey Department of Community Affairs Bureau of Housing Inspections are exempt from this requirement.

§ 85-3. Liability Insurance Required.

The owner of a business, owner of a rental unit or units, and/or the owner of a multifamily home of four or fewer units, one of which is owner-occupied, shall annually register the certificate of insurance demonstrating a certificate of insurance with the Borough of Hopatcong as follows:

- A. Except as provided in Subsection B of this section, the owner of a business or the owner of a rental unit or units shall maintain liability insurance for negligent acts and omissions in an amount of no less than \$500,000.00 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence.
- B. The owner of a multifamily home which is four or fewer units, one of which must be owner-occupied, shall maintain liability insurance for negligent acts and omissions in an amount of no less than \$300,000.00 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence.

§ 85-4. Fee for Business or Residential Unit Certificate.

- A. The Municipal Clerk shall issue the business or residential Landlord a signed copy of their application.
- B. The fee for obtaining a business or residential rental insurance certificate from the Borough of Hopatcong is \$50.00.

§ 85-5. Violations and Penalties.

- A. Any person, firm, or corporation that shall be convicted of a violation of a provision of this article shall, upon conviction thereof by any court authorized by law to hear and determine the matter, be subject to a fine not exceeding \$1,000.00 or imprisonment for a term not exceeding 90 days, or both, as such court in its discretion may impose. Each day that such violation exists shall constitute a separate offense.
- B. The Borough may collect through a summary proceeding under N.J.S.A. 2A:58-10 et seq. a fine of not less than \$500.00 but no more than \$5,000.00 for failing to file with the Municipal Clerk a certificate of insurance registration as required by P.L. 2022, c. 1368.

SECTION II:

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION III:

If any article, section, subsection, paragraph, phrase or sentence of this ordinance is, for any reason, declared to be unconstitutional or invalid, such article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV:

This ordinance shall take effect immediately upon final publication as provided by law.

BOROUGH OF HOPATCONG ORDINANCE # 14-2025

AN ORDINANCE TO AMEND CHAPTER 224 SECTION 224-13 OF THE TOWNSHIP CODE OF THE BOROUGH CODE ENTITLED "TOWING AND STORAGE FEES"

WHEREAS, the Mayor and Council of the Borough of Hopatcong revise Chapter 224, section 224-13 of the Borough Code to set the same in accord with the maximum published rates utilized by the New Jersey State Police.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Hopatcong, County of Sussex as follows:

Section 1: All fees and charges shall conform with the maximum published rates utilized by the New Jersey State Police for towing, storage and other charges, which shall be updated from time to time. The current maximum New Jersey State Police rates are published by Garden State Towing Association, Inc. and are available for review on their website www.GSTA.org. A copy of said schedule of fees is also available for review in the Police Department.

Section 2. Chapter 224-13 Towing Rates shall be modified as follows:

A.The following is the fee schedule for basic automobiles, motorcycles, motorized bikes, towing services and heavy-duty vehicle recovery as established by the maximum published rates utilized by the New Jersey State Police for the year 2025:

- (1) Road Service.
 - (a) Cars (Light): \$150.00 per hour plus parts.
 - (b) Trucks (Medium/Heavy): \$200.00 per hour plus parts.
- (2) Towing Basic
 - (a) Light Duty-Up to 10,000 lbs.: Hook-up \$155.00
 - (b) Medium Duty-10,001-16,000 lbs.: \$300.00 per hour
 - (c) Heavy Duty-16,001 and above: \$500.00 per hour
 - (d) Decoupling Fee (if tow is not performed): one-half of basic rate.
- (3) On-Hook Mileage
 - (a) Light Duty: \$7.00/per loaded miles
 - (b) Medium Duty: N/A
 - (c) Heavy Duty: N/A

- (4) Recovery/Winching (In Addition to Towing-per tuck including driver)
 - (a) Light/Medium Duty: 10,001-16,000 lbs.: \$350.00 per hour charged in one-half hour increments of \$175.00 per half hour.
 - (b) Heavy Duty: 16,001 and above: \$650.00 per hour
- (5) Specialized Recovery Equipment.
 - (a) Rotator/Crane Recovery Unit: \$1,200.00 per hour
 - (b) Tractor with Landoll Trailer or Detach Trailer: \$500.00 per hour
 - (c) Tractor/Transport Hauler Only: \$350.00 per hour
 - (d) Refrigerated Trailer w/Tractor: \$550.00 per hour
 - (e) Box Trailer w/Tractor: \$500.00 per hour
 - (f) Air Cushion Unit: \$1,000.00 per hour

 - (j) Any Other Specialized Equipment: \$300.00 per hour
 - (k) Loader/Backhoe/Telescopic Handler/Bulldozer/Bobcat: \$400.00 per hour for each
 - (1) Forklift: \$400.00 per hour
 - (m) Dump Truck/Dump Trailer w/Tractor: \$400.00 per hour
 - (n) Roll-Off with Container: \$400.00 per hour plus Disposal
 - (o) Recovery Supervisor Vehicle: \$150.00 per hour
 - (p) Scene Safety Equipment, Communication Equipment, Traffic Management Equipment, etc.: \$250.00 per hour each type used
 - (q) Recovery Support Vehicle/Trailer Additional Recovery Equipment: \$350.00 per hour
- (6) Labor All Labor Minimum of One (1) Hour
 - (a) Accident Minor Clean-Up and Disposal of Debris: \$75.00 per hour one Hour Minimum, plus absorbent materials used
 - (b) Recovery Supervisor and/or Level III Recovery Specialist: \$250.00 per hour (*charges limited to one per incident)
 - (c) Certified Towing Operator: \$150.00 per hour per person
 - (d) Manual Laborers: \$125.00 per hour per person
- (7) Storage Per Calendar Day (Inside Rates Two Times Outside Rate)
 - (a) Cars/Light Trucks-10'x 20' Space: \$50.00 per day
 - (b) Trucks (Dual Wheels)/Single Axle: \$125.00 per day
 - (c) Tractor/Dump Truck/Tractor and Trailer Combo/Trailers: \$125.00 per unit per day
 - (d) Buses: \$150.00 per day
 - (e) Roll-Off: \$125.00 per day for each day
 - (f) Cargo/Accident Debris/Load Storage/Vehicle Components 10'x 20' Space: \$50.00 per space used per day
 - (g) Rental of any Tow Company Supplied Trailer Post Incident: \$500.00 per day

- (8) Additional Services/Notes
 - (a) Fuel/Hazmat/Cargo Spills Clean-up and Disposal: Time and Material
 - (b) Hazmat and Trash Recovery: Surcharged 10%
 - (c) Subcontractor Mark-Up: 20%
 - (d) Administrative Charge Only after 3rd Visit to Vehicle: Cars Only-\$50.00
 - (e) Administration Charge: Medium/Heavy Truck: \$200.00
 - (f) After Hours Release: \$85.00
 - (g) Notification Documentation Fee: \$75.00
 - (h) Tarping/Wrapping Vehicle: \$90.00 per car; \$250.00 per Truck

Section 3. Towers engaged in towing for the Borough of Hopatcong shall not charge a fee in excess of the enumerated fees/rates referenced in Section 2 above.

Section 4: All ordinances of the Borough of Hopatcong which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 5: If any section, subsection, sentence, clause or phrase of this ordinance if, for any reason, is held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

Section 6: This ordinance shall take effect upon passage and publication according to law.
