OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

**ROLL CALL:** The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilman Young and Mayor Petillo.

ABSENT: Councilman Padula and Councilman Schindelar.

**MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE:** <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

Mike Obremsky, the Borough's JCP&L Representative, addressed the Council regarding their readiness for the hurricane that was predicted for last week. He also discussed the plans for next year which would allow 911 operators to electronically report outages and problems.

Mayor Petillo thanked Mr. Obremsky and stated that since Hurricane Sandy, JCP&L has provided great response time to the Borough and have kept us up to date. It has made life much easier.

Councilman Francis stated that the briefing prior to the impending storm was excellent.

#### **SALE OF MUNICIPAL PROPERTY:**

John Ursin, Borough Attorney, stated that he has recused himself from participating in discussions regarding the ordinance and the upcoming auction as he has a conflict.

**COMMITTEE REPORTS:** <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the next senior meeting will be held on October 6<sup>th</sup>. She also reported that there will be a "Fall Harvest" Day at the Farmers Market on September 25<sup>th</sup>.

Councilman Francis stated that the market was cancelled this past Sunday due to the impending weather. He also stated that there is a resolution on this evenings meeting which would once again allow hunting in the natural area preserve. The hunters will have to follow all State regulations.

Councilman Young stated that the Environmental Commission had a speaker at their last meeting to discuss invasive plant species. The Commission will be participating in the Fall Harvest Day at the market. Councilman Young also reported that the Recreation Commission met and discussed the Ice Cream Social. It was not well attended so they will reevaluate it next year.

Councilman Bunce stated that there are two ordinances on for consideration this evening regarding the water and sewer utilities, as well as the Developer's Agreement for the Atkins project. He reported that the Crimestoppers 5K/12K run is scheduled to be held at the County fairgrounds and that the Senior Luncheon scheduled for Oct. 23<sup>rd</sup> at 1:00 will once again be co-sponsored by the Knights of Columbus and the Borough Council.

Mayor Petillo reminded everyone about the scheduled Drive-thru Flu Clinic that is scheduled for September 24<sup>th</sup> from 11am to 2pm at the DPW. She stated that it is being done as a test to see how prepared we would be in the case of an emergency where mass inoculations needed to be given. She also stated that the Apple Pie and Arts event will also be held on the 24<sup>th</sup> at the high school from 11am to 4pm. The event will be held in conjunction with the Community College and will feature music and art for adults and children.

Mayor Petillo also reminded everyone of the 15<sup>th</sup> anniversary of the 9/11 terror attacks and welcomed everyone to attend the service being held at 3:00 pm on the 11<sup>th</sup>.

**PUBLIC COMMENT:** <u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning items on the agenda for which no public discussion is provided. (Comments limited to 5 minutes).

Cliff Lundin, 8 Skytop Road, stated that the DEP will be holding a meeting regarding their proposal for the draw down of Lake Hopatcong. He stated that they have written a counter proposal to present to the DEP. The Commission would like to see the decisions be put in the hands of the local representatives because the DEP takes too long to make a decision.

David Harris, 125 Dupont, asked about the donation of 24 Tufts Trail and Councilman Francis stated that the Real Estate Committee will evaluate it to see if it should go up for public auction. Mr. Harris also commented on the hunting resolution, the FEMA grant resolution and the shared services contract with Stanhope for the Court. Mayor Petillo stated that we have had great success with our court shared service.

Robin Nevins, Evans Place asked questions, such as his retirement date, whether or not he is still getting paid and takes benefits and seeing the ad for another BA, about Mr. Elia's retirement agreement. Mayor Petillo stated that the Council would comment when it was time to approve the agreement.

Jerome Mandell, 928 Duck Pond Road, addressed the Governing Body regarding the hunting on municipal property. He stated that he believed that the Natural Preserve should be dedicated to preserving nature, not hunting it. He hoped that the Council would consider not approving the resolution to hunt on municipal property.

After giving all persons present an opportunity to address the Governing Body, Councilman Young made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Bunce. All were in favor.

#### **PUBLIC COMMENT:**

<u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning the good and welfare of the Borough. (Comments limited to 5 minutes).

Sandra Saltman, 19 Winding Hills Road, addressed the Council regarding her water bill and the turn off/turn on charge that she received when her water was turned off for a very short period of time. She stated that she doesn't believe that the charge was fair.

Mayor Petillo stated that the ordinance needs to be followed regardless of the amount of time that is spent rectifying the problem.

Beth Grove, 7 Maple Place, stated that once again there was not report from the Firing Range Committee. She voiced her many concerns regarding the site, including her concerns about soil conservation, wetlands, the trails, safety, noise and the cost.

Eric Grove, 7 Maple Place, addressed the Council regarding the Firing Range site and the Soil Conservation Plan that was submitted to the County. He stated that it was really a grading plan and that the application was non-responsive and that the State was asked to freeze the file.

Mayor Petillo stated that the Firing Range Committee wants to have a comprehensive report before it presents it to the Council and to the public.

Ellen Renaud, 6 Bear Pond Trail, gave the Council a petition, signed by her and her neighbors, asking the town to fix the deteriorating steps off of Bear Pond Trail.

Mayor Petillo stated that she would go out, along with the DPW Superintendent and the Borough Engineer, to take a look at them.

David Harris complimented the Council on the new street lights on Hopatchung Road and discussed the paving on Lakeside Blvd in Morris County, the view of the lake in Landing and the Redevelopment on River Styx.

Terry Walker, 23 Staten Trail stated that she is concerned about eminent domain in the River Styx Redevelopment Plan.

The Council discussed the redevelopment, explaining that the town already has the power of condemnation but that this is not the intent of the Redevelopment Plan. The plan is to revitalize that area by making the designation which will provide grant opportunities, incentives, etc.

After giving all persons present an opportunity to address the Governing Body, Councilman Bunce made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Young. All were in favor.
