CALL TO ORDER: Announce Quorum

Councilman Padula reported that the Redevelopment Committee went down to Seton Hall to watch the presentation regarding the Redevelopment area. He stated that it was very informative and done very professionally. He stated that he would have liked the students to come to present it to the public at a Council meeting but that they have classes on Wednesday nights. He stated that he will get a copy not only of the Powerpoint presentation but the video so that it can be put on our website. It can be used as a tool for prospective investors. It was well worth the \$3,000 that the Borough spent because the information that was gathered will be very valuable going forward.

Councilman Padula thanked Councilwoman Galate for her years of service and for her guidance. She provided him with valuable insight into being a Councilman and on the importance of following procedure. He thanked her for mentoring him.
