# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY OCTOBER 3, 2018 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Francis</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

**ROLL CALL:** The Clerk called the roll and the following members were present: Councilwoman Galate, Councilman Hoferkamp, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Francis.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Francis</u> invited all present to salute the flag and to remain standing for a moment of silence.

# **PRESENTATIONS:**

Hopatcong Girl Scout Troop 94074 - Silver Awards

At this time Mayor Francis presented proclamations to the girls from Troop 94074 for earning their Silver Awards - Joelle Tone, Tamia Louissaint, Dariana Garcia, and Keelyn Cathryn Boström.

**COMMITTEE REPORTS:** <u>Mayor Francis</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the Farmers Market is winding down. There are three more days and one of those will feature Father Peter blessing the animals.

Councilman Hoferkamp stated that the Mayor's Pride Community Service Program is still on-going.

Councilman Young reported that Recreation has not met but that Oct. 14<sup>th</sup> is the Halloween Parade/Contest with a rain date of October 21, 2018. Basketball sign-ups are on-going. The Municipal Alliance will have a table at Back to School night. The Environmental Commission discussed meeting dates for next year as well as the cleanup, the shred day and the tree give-away. On November 3<sup>rd</sup> there will be a lake cleanup.

Councilman Padula stated that Seton Hall is conducting a Market Research Survey for the Redevelopment area. They are getting feedback and looking into people's perception regarding the Redevelopment.
