PUBLIC COMMENT:

Ms. Johnson went on to comment on the 2016 bond with deferred payments and wanted to know if that will be refinanced in 2022; and would the Council consider a Master Ordinance canceling all unfunded balances all sewer ordinances.

<u>Mayor Francis</u> said he is looking into this and will consult the Bond Attorney when the rate study is completed. He suggested Ms. Johnson speak to our CFO or Bond Agent.

Mara Modes wanted to welcome the new BBQ restaurant. She asked about missing minutes from December, and the Wellness Center. Ms. Modes wanted to know who will be using the Wellness Center.

<u>Mayor Francis</u> said there is a calendar in the Borough Hall and there are already some organizations signed up. They have not advertised; all has been done through word of mouth.

Heather Fiore asked about refinancing the 2016 bond.

<u>Mayor Francis</u> said he would talk to the accounting firm and bonding agent, but he did not have an answer.

After giving all persons present an opportunity to address the Governing Body, Councilman Hoferkamp made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Young. All were in favor.
