CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE:

<u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

PRESENTATIONS:

Mayor's Trophy Award - Ryan Clarke

At this time Mayor Petillo and Councilman Young honored Ryan Clarke with the 2014 Mayor's Trophy Award and proclaimed July 2, 2014 as Ryan Clarke day in the Borough of Hopatcong.

Councilman Bunce made a motion to take a ten minute recess. Seconded by Councilwoman Klein. All were in favor.

<u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilman Francis stated that the Farmer's Market is going strong and that he encourages everyone to come out and enjoy the market.

Councilman Young stated that the Recreation Summer camp has begun and is going well. The Recreation Commission and the Environmental Commission are getting ready for Hopatcong Days.

Councilman Bunce stated that there are no changes with the Water/Sewer department and that the Finance Committee is reviewing Capital Projects.

Mayor Petillo stated that contestants are needed for the Miss Hopatcong contest and also for the softball tournaments that are held on July 13th. She also recognized the Senior of the Year, Bill Bulger, for all that he does for the community, especially his charity swims in Lake Hopatcong that he has been doing for 25 years and has raised over \$100,000.00

Mr. Bulger thanked the Mayor and also commented on his support of Dale Sloat as the ACO of Hopatcong.

They were upset that they have not heard from anyone.

Mayor Petillo and Councilman Francis both apologized for not contacting them sooner. They were under the impression that a letter went out. They stated that they would look into the matter and that someone would be contacting them.

Mr. Menegus invited the Council to come to Belvidere to see the organic farm in hopes that they would see that they will be an asset to the market.

Susan Jones stated that she had concerns about the fact that a congressional candidate, Phil King, was at the Farmer's Market recently and was asked to leave because politicking is not allowed at the market. She feels that it is a matter of free speech and that his rights were being violated.

Mayor Petillo stated that it is not that kind of event and she heard he was argumentative with the vendors.

Sue Jones responded that she doesn't believe that Mr. King was being disruptive and that she heard a totally different story.

Councilman Francis stated that there is consistency at the market because they don't allow any solicitation, whether it be the boy scouts, girl scouts or politicians. It is a family event and not a day for politicking

David Harris stated that we need more vendors at the market and doesn't understand why the Borough would turn away any vendors.

Mayor Petillo stated that the Borough will look into the process and contact the farm owner.

Mara Modes asked if the farm in question is organic and Councilman Francis responded that it is. She also stated that if we get rid of peddling in town what would that mean for the vendors at the market.

Councilman Francis stated that the town is more concerned about door to door vendors.

Ms. Modes also asked about the letter that went out to water customers and why the Borough was in violation of testing quarterly.

Councilman Bunce stated that it is a standard DEP letter and that perhaps one of the wells was being worked on at the time of the testing and that is why it was not tested. He stressed that there is nothing wrong with the quality of Hopatcong's water.

Ms. Modes asked if the Borough was fined and Councilman Bunce responded that there were no fines imposed.

After giving all persons present an opportunity to address the Governing Body, Councilman Bunce made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Young. All were in favor.
