CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

ROLL CALL: The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Petillo.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

PUBLIC COMMENT: <u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning items on the agenda for which no public discussion is provided. (Comments limited to 5 minutes).

Mr. Joseph Quinn, 433 Lakeside Blvd., addressed the Governing Body regarding the event that is going to take place at Patrick's Pub the weekend of May 16th. He stated that he has concerns about the music, the amount of people that are going to attend the event and the amount of boats on the lake. He stated that he feels that it is going to be an inconvenience to his family – he has two small children. He wanted to know what the town is doing to make sure that the event doesn't become unruly and out of control.

Chris Smith, 313 Squaw Trail also addressed the Governing Body regarding the event at Patrick's Pub. She stated that she too is concerned that the event will get out of control and wanted to make sure that there is adequate police coverage both on the lake and in the area. She wanted to make sure that if there was more police coverage that the tax payers were not footing the bill.

Mayor Petillo stated that she and others from the Borough have met with the owners of Patrick's Pub to make them aware of our concerns. Patrick is more than willing to work with the town. He told the town that although he can have the music outside on the deck till 9:00 pm that he will bring the bands inside at 6:00 pm and that if the Chief of Police recommended that more police officers are needed that he will pay for them. Mayor Petillo stated that the State Police have also been made aware of the situation and that they are going to have boats out on the lake for enforcement purposes.

Gwen Switzer, 129 Camp Trail stated that her road is in desperate need of repaving and it needs to be swept. She showed the Council pictures of her road and the horrible conditions. She stated that she has contacted the town several times to no avail.

Mayor Petillo stated that she would take a drive over there tomorrow with the DPW Superintendent. She knows that there are many roads in the Borough that are in need of repair but unfortunately there is only a certain amount of money to do so. The roads are looked at every year and they are put on a priority list. The town does receive grant monies for some roads. We would need over 16 million dollars to repave all of the roads in the Borough.

Since that meeting 3 County employees have announced their retirements, including Eskilson and the CFO. The attorney has also announced his retirement. Two people involved in the project from Morris County have also resigned. The County has already lost 24 million in the project and has committed another 7 million. There were no performance bonds and the County basically acted as the bank for the project. The County representatives have been very quiet on the issue and although representatives from the town were interviewed by the Herald, for some reason our comments never made the paper.

Councilman Young stated that he had new business to discuss. He stated that the County open space resolution for taxes expires in August and that the town, if interested in increasing the tax by .5% then we would have to do a resolution in support of the increase and send it to the Freeholders.

Councilman Francis stated that he believes that the Open Space fund is adequately funded and he doesn't see the need for an increase.

Councilman Bunce reported that a fundraiser to support Armed Forces Relief is being held on May 17th at Pavincis. It is the 5th year that the event will be held.
