MINUTES

OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG,

HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY JANUARY 20, 2016

EXECUTIVE SESSION 5:30 PM OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

ROLL CALL: The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Petillo

RESOLUTION FOR EXECUTIVE SESSION:

Councilman Bunce made a motion to adopt a resolution to adjourn into Executive Session to discuss personnel and contract negotiations. Seconded by Councilman Schindelar. All were in favor.

THE <u>OPEN PUBLIC MEETINGS ACT</u> ALLOWS THE MAYOR AND COUNCIL TO EXCLUDE THE PUBLIC FROM A PORTION OF A MEETING IN CERTAIN CIRCUMSTANCES.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF HOPATCONG THAT THE PUBLIC SHALL BE EXCLUDED FROM DISCUSSION OF MATTERS ALLOWED BY NEW JERSEY LAW.

THE EXECUTIVE SESSION MINUTES WILL BE PLACED ON FILE IN THE BOROUGH CLERK'S OFFICE, AND WILL BE AVAILABLE TO THE PUBLIC AS PROVIDED FOR BY NEW JERSEY LAW.

Councilman Bunce made a motion to adjourn out of Executive Session. Seconded by Councilman Schindelar. All were in favor.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

PUBLIC HEARING:

Removal of Block 40805 from the Natural Area Preserve

At this time, Mayor Petillo opened the meeting to the public regarding a proposal to remove Block 40805 from the Natural Area Preserve as required by Ordinance 154-6.

Alice Stolarz, Maple Place asked the Council to consider another site for the range and once again addressed her concerns regarding the noise and safety issues.

Elaine Vigalate, 6 Maple Place stated that she has come up with two alternate properties and asked the Council to reconsider the current location where there aren't as many residents close by.

Councilman Francis stated that he will take a look at both properties that she is recommending and will let her know.

Mayor Petillo stated that we have been looking for a suitable site for over 5 years.

Fred Messmer, 19 Lebanon Trail stated that the current location cuts off one of the trails and he asked the Governing Body to consider opening the range to the public.

Mara Modes asked what the difference is between properties in the Natural Area Preserve and Open Space.

Mr. Ursin stated that he didn't understand her question but stated that properties in the Natural Preserve are restricted by ordinance.

Mayor Petillo stated that this property is not on the "Rosi" list in the Master Plan.

Beth Grove, 7 Maple place, stated that at the last meeting when Councilman Francis was discussing the lake, he stated that the State is in charge and they will do whatever they want. Ms. Grove stated that the town is doing the same thing with the firing range. She asked the Council to table the ordinance and reconsider the location.

Mr. Ursin stated that this is only a public hearing and that there is no ordinance on for introduction this evening.

Melissa O'Brien, 10 Maple Place, stated that she is concerned about her children's safety and that if the range is kept in that location, she doesn't want to live there anymore. She asked the Council to reconsider.

Eric Grove, 7 Maple Place, stated that he and his wife are not in any way against the police but against the site and how it was secretly planned and constructed.

Mayor Petillo thanked everyone for their comments and stated that the Council will consider everything that everyone said. She stated that it is a work in progress.

Councilman Bunce made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Young. All were in favor.

<u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the Senior's first meeting will be on February 4th at 10:00 am and that the group is getting so large that they may be moving their meetings to St. Jude's. She also stated that the Farmer's Market Committee is going to be meeting next week to discuss this year's upcoming market.

Councilman Young reported that the Recreation Commission held its reorganization meeting last week. They discussed the great turn out for the last movie night. Approximately 150 people attended. He also stated that the Basketball program is up and running and there was some discussion about fees for the spring Street Hockey program.

Councilman Bunce reported that the Finance Committee is working on the budget. He also welcomed Steve Kucevic as the new Fire Chief. Councilman Bunce also reported that the DPW is ready for the upcoming snow. He also announced that Crimestoppers is now taking calls regarding cases doing with cruelty to animals.

Councilman Padula reported that he met with the Chief of Police on Monday and he provided statistics regarding the firing range. It is an ongoing project and they are taking every safety precaution.

Mara Modes asked if the grant monies covered soft cost and Mayor Petillo responded that they aren't covered.
