Before I begin, I would like to acknowledge, Sylvia Petillo, our former Mayor and newly elected Freeholder. Sylvia is the best thing that has ever happened to our town. Her tireless efforts to improve the quality of life for our residents, has given us a brighter future. I owe her a great debt of gratitude for her leadership, guidance and unshakeable faith that helped me become a better elected official, but more important, a better person. Thank you Sylvia, I miss you and wish you God's Speed as you serve on the Freeholder Board.

I would like to congratulate, Frank Padula, on his re-election to Council. You share a love and pride in Hopatcong and have been actively involved in this Borough for many years. I look forward to serving with you.

Now I would like to take a few minutes to thank the many people who dedicate themselves to serving the residents of Hopatcong throughout the year.

Our Business Administrator, Vic Marotta, our Borough Clerk, Catherine Schultz, our CFO, Lorraine Rosetti and all of our employees. Their commitment and unwavering dedication to the residents of our Borough is exceptional. Thank you!

Our professionals who guide us and give sound advice throughout the year. Greatly appreciated!

Our Police Chief Bob Brennan, for his strong leadership, and performance of the Police Department, our supervisors and officers for their professionalism and integrity, our dispatchers for the outstanding work they perform during emergencies and the day to day assisting of our residents. Our police department continues to collaborate with many neighboring police departments to fight the war on drugs and they have been very successful. Their efforts truly make a difference.

Our fire department for their volunteerism and concern for public safety. I appreciate the time and sacrifices that our volunteers and their families make in order to train, respond and meet all the duties required.

The Superintendent of the Department of Public Works, Ron Jobeless, for his outstanding leadership and accomplishments. The DPW staff are amazing men who work quietly behind the scenes, building new projects, repairing trucks and keeping roads clear, plowed, and salted all hours of the day and night. They are the best!

Rob Lawler, our Water and Sewer Supervisor for maintaining our water and sewer utilities. His staff works not only during the day but they are on call for all emergencies to assure that our systems are in good working order.

Steve Millian and our CERT Volunteers who make themselves available to assist whenever needed. The list of activities and emergencies that they respond to are quite extensive. They are outstanding volunteers.

The Ambulance Squad for their quick response to calls and their willingness to help whenever we need them.

All of our departments and agencies are united in their efforts to keep our community safe. They are remarkable men and women and again I want to thank all of them for their service and the sacrifices they make to bring Hopatcong through the many challenges we face each day.

Six years ago the Council and I announced our vision for redevelopment in River Styx. Our intent was to initiate a strategic plan that was tailored specifically for the River Styx Peninsula to foster a redevelopment project that would revitalize the entire business district. Since then the Borough Council and the Land Use Board have also focused their attention on establishing an economic development plan that would further economic growth throughout the entire Borough. I am glad to report that the first building "Brookland" constructed by Greentree Development is complete and they are now building 9 luxury condominiums on the former Mad House property.

This year the Borough will continue to work to statutorily designate the River Styx area as "An Area in Need of Redevelopment." This designation will enable the Borough to seek Federal and State money for the infrastructure improvements.

Another redevelopment project that is on the rise is "Mariner's Pointe." The Atkins Group has started construction on 35 luxury townhouses that are situated on a ten-acre lakefront parcel in the Garden's section of the Borough. It is a beautifully environmentally sound concept that will showcase Lake Hopatcong and enhance the entire area. As part of their project they will build a group home for SMILE's, an organization for special needs teens and young adults.

All of these projects will continue to grow and strengthen our community. They will also provide a much needed economic boost to our business districts.

Tonight, I would like to commend the Borough Council and the Land Use Board who shared a vision for progress, listened to the residents in our community and utilized the resources available from the state and the county to produce good planning initiatives that will encourage economic development in all of our business centers as we move forward in 2017 and beyond.

Now, let's talk about all of the projects that we completed in 2016 under the supervision of our DPW Superintendent, Ron Jobeless.

The DPW built an additional salt storage building to make sure the Borough does not run out of salt for our roads.

Final plans for a truck wash are completed. This project will bring the Borough into compliance with state and federal regulations.

The basketball court at Modick Park underwent a complete transformation including lights for night games.

At Veteran's Park and field beautiful street lights were installed in the parking lot for public safety.

The \$268,000 D.O.T. Enhancement grant for Phase II of the Hopatchung Road Street Scaping Project was completed. This project included numerous street-lights, curbing and drainage. It really is beautiful.

We are moving into 2017 with a financially stable budget. We will continue to review and evaluate each department in order to enhance the efficiency of services while keeping expenses stable this year.

Our Bond Rating was raised by Standard and Poors Global Rating to an AA+. This is important because it shows just how well our finances and budgets are being managed. It also shows that we have a Very Strong capacity to meet our financial commitments. There are very few towns in New Jersey that have AA+ratings.

This year, we had another successful Farmer's Market. I want to thank Marie Galate for helping me get the market going, the vendors for coming and the residents for participating. We hope to see you again this year!

Our Senior Center underwent a change this year with our new Recreation Director, Cathy Millian. Under her leadership our senior center has grown and is now the largest senior group in Sussex County.

This year "The Hopatcong Creative Arts Council" was formed to foster an awareness and knowledge of cultural diversity for public enjoyment and enrichment for all ages. They planned their first event this September "Apple Pie and Art" and it was a huge success. The event was co-sponsored by the Borough and Sussex County Community College and held at Hopatcong High School.

What a wonderful creative collaboration between people, artists and institutions. Thank you to all involved.

Their second event was Snowman's Park. That was another successful venture. The snowmen were individually created from a wood form and wild imaginations. It was a delightful activity and lots of fun.

I can't wait to see what their next event will be!

Before I end, I would just like to acknowledge Bill Wagner, his family and friends who worked tirelessly for months to prepare for their wonderful presentation of the Christmas Spectacular. He brought the beauty of Christmas alive once again and smile's could be seen on everyone's faces. This year Olaf showed up and joined the cast of characters that entertain the crowds. Although the weather didn't cooperate on the second weekend as we had hoped, Mr. Wagner stayed the course and came back on Christmas Eve. Children from one to 92 were captivated by the enchanted evening.

The Cub Scout volunteers served delicious hot chocolate in an effort to keep everyone warm along with Marty and the warming bus. But the wind and cold did not dampen anyone's spirits. The winds blew hard, the lines were long, but the magic of Christmas filled the air every night and brought laughter and joy to all who believe!

Throughout the year we recognize excellence in the accomplishments of our residents. I would like to recognize Sam Schindelar for earning his Eagle Scout Award and Lara Watrous for earning her Gold Award. These accomplishments required a tremendous amount of work. Scouting is a very important part of the fabric of our town.

It is the people in our community that give so much that makes Hopatcong a very special place to live.

I am very proud to serve as Mayor of Hopatcong and what we have accomplished in the last few years together. I look forward to continuing our vision, establishing new goals to improve the entire community and making Hopatcong a better place to live.
