# MINUTES FOR THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY DECEMBER 7, 2016 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Francis</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor notes fire exits)

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Francis</u> invited all present to salute the flag and to remain standing for a moment of silence.

**ROLL CALL:** The Clerk called the role and the following members were present: Councilwoman Galate, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Francis.

Absent: Councilman Bunce

**COMMITTEE REPORTS:** <u>Mayor Francis</u> allowed each member of the Council to present their respective committee reports.

Councilwoman Galate stated that the next meeting of the Senior Inc. group will be on February 2, 2017. She also reported that she is trying to set up a Police Committee meeting and that the police will be running their "Drive Sober or Get Pulled Over" campaign from December 9<sup>th</sup> through January 1<sup>st</sup>.

Councilman Young stated that the Environmental Commission meeting was cancelled this month and that they are working on the "trial sign" project. He also stated that the Recreation Commission discussed the basketball program and next year's events. He reported that the movie night was a huge success and that it was very well attended. Councilman Young reminded everyone that the Christmas Spectacular will be held on the 9<sup>th</sup> and the 10<sup>th</sup> and 17<sup>th</sup> in Modick Park.

Councilwoman Galate stated that Bill Wagner, the organizer of the event, spoke to the Seniors and that they will be holding the Spectacular on Sunday the 11<sup>th</sup> from 6:00 pm to 8:00 pm just for the seniors and those who are handicapped. There will be a warming bus and line waiters in case they have to sit down while waiting for Santa. She stated that after the event is over for the year, Bill Wagner will be donating the trees to those in need.

Councilman Padula reported that the DPW and Water/Sewer Committees will be meeting next Tuesday and that they will be discussing the water service applications. He also stated that the Land Use Board, at last night's meeting, voted to recommend to the Governing Body that they deem the River Styx area as an area in need of redevelopment.

Councilwoman Galate thanked Ron Jobeless and Mike Juskus for all of their hard work that they put into for the "Snowman Park" outside of the municipal building.
