# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY SEPTEMBER 19, 2018

**OPEN PUBLIC MEETING 7:30 PM** 

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Francis</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

**ROLL CALL:** The Clerk called the roll and the following members were present: Councilman Bunce, Councilwoman Galate, Councilman Hoferkamp, Councilman Schindelar, Councilman Young and Mayor Francis.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Francis</u> invited all present to salute the flag and to remain standing for a moment of silence. <u>Mayor Francis</u> asked that we remember Jim Franco of the Fire Department and keep him in our prayers.

**COMMITTEE REPORTS:** <u>Mayor Francis</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the Farmers Market is every Sunday from 9am to 2pm. They have had four rain out Sundays but are still going strong with a lot of new vendors.

Councilman Hoferkamp congratulated Roy McQueen for winning Sussex County Senior of the Year. Councilman Hoferkamp reported that we have a received a new Senior Bus and thanked Ron Tappan for all his work towards getting it; the ribbon cutting ceremony will be tomorrow. Councilman Hoferkamp thanked Cathy Millian for her work on the 9/11 ceremony. Councilman Hoferkamp reported that the town wide cleanup was a success; Jule Girman and Georgia Schilling recruited 120-130 people including boy scouts, girl scouts, and people from the County.

Councilman Schindelar reported that the real estate committee had met and that they will be bringing new properties to auction.

Councilman Young reported that at the Recreation Committee meeting they discussed that camp had ended and there was a few weeks between camp ending and school beginning (they had a total of 190 campers). The Halloween Parade and Costume Contest is scheduled for October 14, 2018 with a rain date of October 21, 2018 and will start at Hudson Maxim. Councilman Young reported that bowling was tough last year due to the time it was held and scheduling with the bowling alley; therefore there will be no bowling this year so that they can come up with a better plan for the future. Councilman Young reported that the Environmental Commission's town wide clean up went great (they gave out bags and gloves); Jule Girman was at the Farmers Market advertising it and she put up signs around town. September 15th was also Shred Day. September 22, 2018 starts the lake draw down and November 3, 2018 is lake cleanup day. The Environmental Commission discussed creating a rain garden. Councilman Young commented that there were fewer kids at Hopatcong Days this year. The Environmental Commission also discussed the no idling Ordinances, Councilman Young reported that the Governor issued an executive order making it illegal to hunt bear on State property.

Councilman Young reported that the Municipal Alliance movie night went well and they plan to host a seminar called "Parents Who Host Lose the Most". They will also be at back to school night with an anti-drug message.

Councilman Young commented that Miss Hopatcong, Samantha Schuman, competed at the Queen of the Fair Pageant and did a great job; Miss Vernon won the pageant.

Councilman Young mentioned that we lost Jim Franco who was on the Recreation Commission for many years.

Councilman Bunce endorsed the water application that is on the addendum. Councilman Bunce stated that the Fire Department won't be the same without Jim Franco and that he meant a lot to this town; he will be missed and sympathies to his wife.

Mayor Francis congratulated Councilman Young for receiving an award from the County regarding Municipal Alliance.
