CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: Mayor Petillo stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor notes fire exits)

ROLL CALL: The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilwoman Klein, Councilman Young and Mayor Petillo

Councilman Bunce made a motion to excused Councilman Hoer. Seconded by Councilwoman Galate. All in Favor.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

COMMITTEE REPORTS: <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate – Nothing to Report. Meetings were cancelled due to the snow & ice storms.

Councilman Francis – The Energy Committee met and toured the Landfill with PSE&G and another interested party regarding solar energy. Communicated with Jersey Central to see if they would like to partner and have not heard anything yet.

Councilman Young – Recreation has not yet met. They are starting to look into Summer Recreation Program. They are planning a spring field walk sometime in May/June when the snow melts.

- Environmental met in January and finished their annual reports. They will continue the Earth Day Hike and interested in starting a new project to fix up the Welcome to Hopatcong signs. Lake Hopatcong Foundation is looking to partner to bring educational classes to the schools. They completed an ice safety class in Durban School and St. Theresa's in Roxbury. The water testing on Musconetcong was done in January.
- Open Space Nothing to Report

Councilman Bunce – The DPW has been very busy repairing its equipment, working on getting salt and opening drains after all the storms.

- Finance is working on the 2014 Budget
- Water/Sewer is working on marketing the water system
- Citizens are asked to help with digging out the fire hydrants, along with the volunteer firemen, to clear away the snow from the fire hydrants. We also need a better way to identify the location of the fire hydrants, especially in light of the 4 feet of snow.

The employee, Marie Filoso, received a Rice Notice, and elected not to revoke her right to have the discussion held in public session.

A motion was made by Coucilwoman Galate to accept the recommendation of the Hearing Officer and follow the recommendation of Termination of the employee, Marie Filoso, effective immediately. Seconded by Councilman Francis.
