#### Field Request:

Lake Hopatcong Foundation holds a license which can highlight Hopatcong assests, such as trails and promote free events. Not meant for team sports, but to get people aware of the trails surrounding out area. Is targeted to low-income and to be used for as many free activities as possible. Commissioner Ostman asked if Bocci Ball could be advertised, yes it can. Chairperson Sutton asked about app for phone and yes is available

for phone. There are also challenges or games such as the Liffy Island Challenge. It can also be sued for surveys. The app is very popular with big parks on the West Coast. Hopatcong Borough would provide all information to insure it is accurate.

Resident Comerford spoke about volleyball at St. Judes at parish or outside and that Manny Fernandez should be contacted. He also stated that Street Hockey wrapped up on Sunday and thanked Commission Vinkman for her presence. The kids had fun and there was a lot of good energy. Thank you to the parents for providing the food. They have a miniature "Stanley Cup" with a plate of the winning team each year. Even though the season is over, the nets are left out all summer. Commissioner Barella asked if they needed new nets. They will be ordered over the winter.

New landscaper (L&L Landscaping) is doing a good job but could use some weed killer because the weeds effect the play.
