# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY JUNE 18, 2014 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." Dale Sloat, 320 Hudson Avenue, made a statement of his intention to reture as of June 1 next year. He requested that certain items be revised/removed from his agreement with the Administrator. He will have a meeting with his direct supervisor and management to discuss the details.

Arlene Trumpore Cramer, 42 Wildwood Shores Road, requested a meeting in private with the Mayor and/or Administrator regarding a number of facebook printouts she wants to share with them.

**COMMITTEE REPORTS:** <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the Seniors would be holding a meeting on July 3 at 10am. She also shared that approximately 96 people attended the installation of officers meeting held this year. The Senior Picnic will be held on June 28 and the Hopatcong Farmer's Market is scheduled to start again on June 15 from 9am-2pm.

Councilman Francis is excited that the Farmers Market will be reopening on Sunday. He also stated that the Real Estate committee has been working hard and you will see an aggressive approach to trying to return property back to the tax rolls with future Auctions of Property.

Councilman Young reported that the Recreation Commission is working hard. They are finalizing the Recreation program which starts in 10 days. Hopatcong Days, Ice Cream Social and Movies in the Park are some upcoming events.

Councilman Bunce reported that the DPW is 50% complete with their maintenance of the winter equipment getting ready for next year and work will begin soon for a new Salt Bin. The Finance committee will hold a mid-year review next week. Water and Sewer will be finalizing the Grease Trap Ordinance.

Councilman Padula shared his experience with a new website called Nerd Wallet that listed Hopatcong as the 7<sup>th</sup> Best Place To Live In the State of New Jersey and that 92% of the homes are owned by residents and that the taxes are paid by homeowners not commercial property owners. Hopatcong is an Affordable place to live.
