# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY JANUARY 21, 2015 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

**ROLL CALL:** The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Petillo.

**MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE:** <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

### PRESENTATION:

At this time members of the Lake Hopatcong Foundation addressed the Governing Body regarding their upcoming events, including their trails project, the purchase of the train station building in Landing, the upcoming Block Party and the Lake Loop bike ride.

**COMMITTEE REPORTS:** <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the Seniors Inc. group meets on the first Thursday of each month and that they have many trips planned for the 2015 year. She also reported that the Farmer's Market is on track for 2015. A lot of the same vendors have indicated that they will be returning this year.

Councilman Francis reported that the Finance Committee has made great progress on the budget and that it is looking good for this year. He also reported that he is looking into a grant for LED lighting. The Real Estate Committee is meeting next Monday.

Councilman Young reported that the Recreation Commission held its reorganization meeting and that Cathy Millian was once again picked as Chairperson. He stated that she does a good job. He also stated that the bowling and hoops program are going well. Right now the Commission has begun planning the Easter egg hunt. Little League is in charge of buying the candy for the eggs this year. The sports leagues take turns. The Commission is also looking into buying a piece of equipment that would allow the basketball hoops in Hudson Maxim School to be lowered so that the little kids can shoot.

Councilman Bunce reported that he also agrees that the budget is looking good for this year. He stated that the DPW is in the midst of winter, plowing, salting, etc... He asked the Mayor to contact the DEP again regarding our salt shed. It is desperately needed. Councilman Bunce also reported that we had money left over from the EPA grant and that we are going to construct another hundred feet of water mains. He also stated that he met with the fire department chiefs and that they are planning for the Firemen's Parade and have received bids for the new showers in houses 2 and 3.

**PUBLIC COMMENT:** <u>Mayor Petillo</u> opened the meeting to the public for any questions or comments concerning items on the agenda for which no public discussion is provided. (Comments limited to 5 minutes).

Mr. Rehe voiced his concern regarding the request from the owner of 508 Nariticong Avenue to use public property for his own use. He stated that he doesn't believe that it should be allowed.

Mr. Mazzolla, the owner in question, stated that he got a warning notice from the Zoning Officer to remove the items and that he is here because he wants to ask the Governing Body for relief. He stated that Mr. Rehe also has items on municipal property.

After giving all persons present an opportunity to address the Governing Body, Councilwoman Galate made a motion to close the meeting to the public and return to the regular order of business. Seconded by Councilman Bunce. All were in favor.

He stated that he is also in the process of working on the shared service agreement with Stanhope for Animal Control services.
