CALL TO ORDER: Announce Quorum

Councilwoman Galate stated that this coming Sunday is the last Farmer's Market. Next year's market will begin on Father's Day, June 15, 2017. She also reported that the Seniors Inc. group will be meeting tomorrow at 9:30 am at the Senior Center. She also

reported that our Fire Department took two first place trophies at the annual Firemen's parade and that the Hopatcong High School Marching Band received a third place trophy.

Councilman Francis stated that there will be a boat show at this week's Farmer's Market.

Councilman Young reported that the Recreation Commission was busy setting the 2017 dates for their yearly events and also that their calendar of events will be available on their Facebook page. He stated that the Summer Recreation program is over for this year and that the Halloween parade will be held on October 16, 2016.
