COMMITTEE REPORTS: <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilman Bunce reported that the DPW salt shed is up and that the DPW is currently working on maintenance, getting ready for another winter.

Councilman Young reported that the Firing Range Committee is nearing the end of the exploration stage. They have met with the engineer and have reviewed 12 locations. 8 of those were eliminated and the remaining 4 are being looked at with regard to cost, viability, safety etc.

Councilman Young also reported that the Recreation Commission had a meeting and that 158 campers have signed up for the Summer Camp. They also discussed the upcoming Hopatcong Days celebration.

Councilman Young stated that the Environmental Commission held their National Trails Day Hike and that 15 people attended. They may move it to another time of year next year as June is very hot. He reported that Sussex County Day has been rescheduled for September 18, 2016. He also reported that the newly formed Creative Arts Council will be holding an "Apple Pie and Art" event on September 24, 2016.

Councilman Schindelar stated that this Saturday is Hopatcong Days and that he hopes everyone attends.

Councilman Francis reported that the Farmer's Market is in full swing and that all of the vendors are doing very well. The market is dog friendly and the alpacas are at the market, making it a fun time.

Councilman Francis also reported that the Deer Management Task Force will be meeting soon and that they will be making a recommendation to the Council regarding this year's hunt. He also discussed his plan for a "Forest Management Plan". If we have a plan it will allow the Borough to apply for grants which can be used for mapping and inventory of our forests.

Councilwoman Galate stated that the "Dog Dayz of Summer" event will be held on August 14th at the Farmer's Market. There will be many vendors with dog related products. She also stated that this Friday will be the "Miss Hopatcong" pageants. She reported that Hopatcong Days is this weekend and that the Senior picnic was held last weekend and that 169 people attended. Nancy Smith and Henry Schmidt were names the 2016 "Seniors of the Year".

Mayor Petillo thanked the Lake Hopatcong Foundation for hosting the Cruise for Veterans this past weekend. She stated that it was very well attended and that it was very touching. It was a beautiful tribute to those who sacrificed so much of themselves.
