MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY MARCH 16, 2016 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

At this time, Mayor Petillo honored outgoing Cub Master Mike Nicotra for his six years of dedicated service to Pack 88.

COMMITTEE REPORTS: <u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilman Young reported that the Gun Range Committee has met to discuss the members reporting responsibilities and that as of yet, they don't have any information to share with the Council. He also reported that the Open Space Committee met and discussed the County Master Plan and the grant that was received for trails in Hopatcong. Councilman Young stated that the Recreation Commission has been signing up participants for the Street Hockey program and that this Sunday, March 20th is the Easter Egg Hunt.

Councilman Padula stated that there is a DPW meeting scheduled for this coming Monday and that the newly formed Redevelopment Committee will be meeting on April 5^{th} .

Mayor Petillo stated that the Drug Alliance will be running program in the high school on April 19^{th} from 6-8 pm. The program called "Hidden in Plain Sight" will teach parents where to look for drugs that may be hidden in their children's bedrooms.

<u>Discussion – Request to Vacate a Portion of Shawnee Road</u>

At this time a discussion will take place regarding a request to vacate a portion of Shawnee Road.

Mr. Ursin stated that this issue has come up many times before. The dock at the end of Shawnee, which is owned by the Borough is in disrepair. A few years ago he recommended that either the Borough vacate the property or at least put up a fence that would prohibit people from accessing the dock. He stated that he had encouraged the residents who had deeded access rights to get together to form an association so that we could vacate the property to them and they would have control over the dock. Shawnee is also a fire lane and before it is vacated he recommended that the Council consult with the Fire Department. If the Borough does wind up vacating the property, then any disputes over the access would be a private matter.

After discussion, the Council directed the attorney to draft an ordinance for introduction. They also stated that they would consult with the Fire Department regarding the fire lane issue.

David Harris asked if it would still be private property and Mr. Ursin stated that there would only be an easement for those who have deeded access rights to the lake. Mr. Harris stated that he is glad to see the kids enjoying the basketball courts and asked if the parts for the skate park have come in.

Mayor Petillo stated that we have the parts and the DPW will be scheduling the repair when they have the time.

Mr. Harris also stated that he is impressed with all of the hard work that the Council did on the budget. He asked if the office remodeling project is included in the budget and Mr. Elia responded that it was included in last year's budget. Councilman Francis stated that a lot of the work was done in-house.

Mara Modes asked if we had a new ACO and Mr. Elia responded that we didn't.

David Hughes stated that there is no lock on the gate down at the end of Shawnee.

Robert McGoldrick stated that he is not in favor of vacating fire lanes and wanted to know why some of them aren't maintained.

Councilman Francis stated that the Council will be taking the advice of the Fire Department.
