MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY MAY 17, 2017

OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Francis</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

ROLL CALL: The Clerk called the role and the following members were present: Councilman Bunce, Councilwoman Galate, Councilman Hoferkamp, Councilman Padula, Councilman Schindelar, Councilman Young and Mayor Francis.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Francis</u> invited all present to salute the flag and to remain standing for a moment of silence.

COMMITTEE REPORTS: <u>Mayor Francis</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate reported that the Farmers Market preparations are coming along and that it begins Father's Day weekend.

Councilman Hoferkamp stated that the Tree Giveaway was very successful and that they will be giving the trees that they have left out during the Hudson Farm Hike.

Councilman Schindelar stated that the Real Estate Committee has recommended several Borough properties that can be put up for auction and that three of them are on the agenda tonight for consideration.

Councilman Young reported that the Recreation Commission met and reviewed the recent basketball program. He also stated that Summer Recreation sign-ups are scheduled for this Saturday but that sign-ups are also held during the week at the Senior Center. He reported that the Municipal Alliance is teaming up with the school and that they are working on hosting a program "Parents who host, lose the most". They are also working on Project Graduation and are considering obtaining a clothing bin in town. Councilman Young also updated the public on the scheduled "Movie Nights" – 06/21, Beauty and the Beast; 07/22, Sing; and 08/13, TBA.

Councilman Bunce stated that he would like to pull the water application submitted by the owner of 469 River Styx Road be pulled off of the consent agenda because there are no costs reflected on the application. He reported that the Memorial Day Parade is scheduled for next Saturday, the Armed Forces Relief event will be held on May 21st at Pavinci, and the Crimestoppers Sheriff's Reception will be held on May 25th at the Farmstead Golf Course.

Councilman Padula stated that the Redevelopment Committee met on Wednesday and the draft Redevelopment Plan is still being reviewed. He stated that he hopes that the plan will be before the Governing Body for consideration at the next meeting.

Mayor Francis thanked the Committee for all of their hard work on the Redevelopment process. The Mayor reported that the Rabies Clinic was held on Saturday, and despite the rain, approximately 300 people took advantage of the event.
