MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY AUGUST 6, 2014 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

OPEN PUBLIC MEETINGS ACT STATEMENT: <u>Mayor Petillo</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

ROLL CALL: The Clerk called the role and the following members were present: Councilman Bunce, Councilman Francis, Councilwoman Galate, Councilwoman Klein, Councilman Padula, Councilman Young and Mayor Petillo.

MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE: <u>Mayor Petillo</u> invited all present to salute the flag and to remain standing for a moment of silence.

Captain Tina Kraus introduced Daniel Kern, the new police officer whose resolution to hire him is on this evening's agenda. Officer Kern has been with the Andover Township Police Department for the last 10 years and has worked as a dispatcher here in Hopatcong. Captain Kraus stated that the Department is very excited to have him join the police force.

Mayor Petillo introduced the JCP&L representative, Michael Obremski to the Council. Mr. Obremski discussed all of the new policies that are in place regarding outages in the Borough. He thanked the police department and Officer Haffner for their cooperation when the company needs traffic control.

Councilwoman Galate reported that the Senior's Inc. will meet at 10:00 am tomorrow. She also stated that the Farmer's Market is doing well.

Councilman Francis stated that the Deer Management Task Force will meet this coming Friday to discuss this year's hunting season with regards to municipal property.

Councilman Young stated that the Summer Recreation Program is in full swing and that there are about 105 campers this year, an increase of about 15% from last year.

Councilman Bunce reported that there will be a water and sewer committee meeting later this month and that the DPW is working on the new salt shed and getting the salters ready for the coming winter. The new roof is being put on the DPW building as well.

Mayor Petillo reported that blue algae has been discovered in the lake and that samples have been taken from the Crescent Cove area. The algae is not toxic but could cause a rash if someone were to swim in the water.

Mr. Rehe, 501 Nariticong Avenue addressed the Council regarding the lack of locks on the ball field next to his house. Mayor Petillo responded that she has sent the issue to the Recreation Commission to review and in turn they will make a recommendation to the Council.
