CALL TO ORDER: Announce Quorum

COMMITTEE REPORTS: <u>Mayor Petillo</u> allowed each member of the Council to present their respective committee reports.

Councilwoman Galate stated the trip schedule for the Seniors has been set, as well as their picnic that will be held on June 28th from 12-3. She also reported that the plans for this year's Farmer's Market are moving along and that the Business League's last meeting was a great success. She also reported that the Police Committee had their first meeting two weeks ago.

Councilman Francis reported that the Deer Management Task Force will meet in May and they may ask for feedback from hunters and that they may consider extending the season by a week. He also addressed the ever growing problem of Lyme disease.

Councilman Young reported that the Environmental Commission will be doing a tree-giveaway on Saturday at the DPW garage this Saturday from 9 – 2. They have about 1,000 trees to give away. He also reported on some of their other planned activities. He stated that the Recreation Commission is working on such things as Hopatcong Days, Summer Recreation Program, Movies in the Park and the Easter Egg Hunt.
