CALL TO ORDER: Announce Quorum

He explained how a consolidated school system would result in significant savings to the taxpayers of Sussex County, via less administrative staff and other personnel and ultimately lower property taxes.

Councilman Padula stated that the resolution could perhaps include asking the State to conduct a feasibility study.

David Harris asked about the resolution that would hire a "Confidential Aide to the Mayor" and the Mayor explained that the employee would be running the "Community

Service program, 6 hours a week on Saturdays, in conjunction with Sussex County Probation.

Mr. Harris asked if the hunting area would be the same as last year and the Mayor responded "yes".

Mr. Harris asked about the resolution to purchase a fire truck and Councilman Bunce responded that it cost approximately \$570,000 and that it was in last year's capital plan.

Memorandum of Agreement - NJDEP

At this time a discussion took place regarding the email that was sent today from the DEP regarding the MOA and its reference to the Borough's septic ordinance. They did not give a clear answer as to whether or not our ordinance was sufficient to meet the requirements of the MOA. Councilman Bunce stated that if there is any chance that this will affect our taxpayers, then he will never agree to it. Councilman Schindelar stated that perhaps the Borough can take the money for the first two years and then opt out in the third year.

Robert McBriar, Borough Attorney, stated that the Council should defer to John Ruschke, the Borough Engineer regarding the ordinance.

Mayor Francis stated that he believes that the Borough would be covered with the ordinance, the County ordinances and the Highlands regulations. He agreed, however, that they should have the Engineer confirm. He also agreed with Councilman Padula that the DEP's answer was very ambiguous and that in no way can it affect the Borough taxpayers.

Marty Kane, a representative of the Lake Hopatcong Foundation, stated that the DEP believes that they gave the town the answer but that further clarification is definitely needed. He stated that the DEP has extended the deadline to agree to the MOA to the end of the month.

Mayor Francis stated that if the DEP really wanted to give us the money, they would have given it to us without stipulation. The paragraph in the MOA regarding septics is a deal breaker for him. He will have John Ruschke review. The DEP made septics the issue when it wasn't necessary.

Councilwoman Galate stated that the DEP needs to give us a definitive answer before she would agree to the MOA.

David Harris stated he was glad to see the fountain in Maxim Glen working. Mr. Harris asked about the Eastern Datacom resolution and Councilman Padula stated that it is for new security cameras.

Mr. Harris asked if the police had body cameras or cameras in their cars. Mayor Francis responded that they don't have body cameras but do have them in the police vehicles.
