COMMITTEE REPORTS:

<u>Mayor Francis</u> allowed each member of the Council, to present their respective committee reports.

Councilwoman Galate stated that the Farmer's Market is coming along – the invitation letters are in the process of being mailed out. She stated that this year there will Baking Contest at the market.

Councilman Hoferkamp stated that the schools are offering a "pre-play" event for the seniors. The play this year is Cinderella and the Substitute Fairy Godmother. He also stated that the Environmental Commission informed him that the tree giveaway needs to be cancelled because the State ran out of trees.

Councilman Schindelar asked the Council to vote in favor of the introduction of the ordinance to auction off two pieces of property and to adopt the Meuse Road vacation ordinance. He also stated that he attended the MSA meeting.

Councilman Young stated that the Recreation Commission discussed the possibility of rescheduling the Easter Egg Hunt to the High School gym in case of inclement weather. He also stated that the Summer Recreation schedule needs to be adjusted, as well as the fees, because of the bad weather. There will be a resolution on for consideration at the next meeting. He also stated that they discussed policy changes regarding use of electronics at Summer Recreation. They decided not to make any changes. He also stated that the Street Hockey program will be starting shortly. He congratulated the DPW on a job well done with the snow.

Councilman Bunce stated that the DPW is working on the trucks after the recent storm. He also commented that the Finance Committee has done a great job with the budget.

Councilman Padula stated that the Redevelopment Committee will be meeting with John Ruschke to discuss the Street-Scaping Project and the Seton Hall Project.

Mayor Francis stated that the Borough has instituted a new Emergency Alert System called Nixle. If you want to be a part of it you have to text the word Hopatcong to 888777. It is a powerful tool to help the municipality get out important information. Residents can also respond with a tip.

ADMINISTRATOR'S REPORT: At this time, Borough Administrator, Ron Tappan, presented his report for the meeting of March 14, 2018. He also reported on the new Nixle Emergency Alert System. He also reported that there is a resolution on for consideration this evening to approve a shared service with the schools to allow for a police officer in the schools.

She stated that she expects that the issue be brought before the Planning Board for a full review. She wants to make sure that noise issues are addressed as well as consideration of financial costs, emotional costs etc. She stated that she has worked very hard to save them money to purchase this property for the rescue and believes that it will be detrimental to the dogs that she is trying to rescue.

Terry Walker, Staten Trail, stated that she would like the town to consider for next year that the taxes and utility bills not be due on a weekend. Councilman Bunce stated that the payments can be dropped off in the box and that the date will be honored.

Jeff Guttenberger,16 Beacon, stated that he loves to hike in the woods and doesn't like the fact that the plans are being done in secret.

Diana Mario, 119 Bergen, stated that she hopes that the Council can insure the safety of the residents wondering by.

Mayor Francis stated that nothing will happen on that property until all of the studies are done. He said that we need to meet a certain criteria for a Police Training facility as well as a tactical training facility.

Councilman Young stated that it will be built according to NRA specifications.

Michelle Guttenberger, 16 Beacon Road, addressed the Council regarding the previous range, stating that the Council did not do the right thing. She read an article published in the NJ Herald regarding the range. She stated that the range will affect peoples' property values.

John Kowalchuk, Sparta, addressed the Council regarding the shelter. He stated that he volunteers at OSCAR and is not satisfied with the response that the Council will update the public when they can. He stated that they are a hardworking group and can't believe that a decent person would vote to hurt animals.
