CALL TO ORDER: Announce Quorum

COMMITTEE REPORTS:

<u>Mayor Petillo</u> allowed each member of the Council, to present their respective committee reports.

Councilman Francis stated that the Farmers Market is holding its Fall Festival on the 25th. There will be a boat show and many other vendors.

Councilwoman Galate stated that the Seniors went on a New England Cruise and that everyone had a wonderful time. She also invited everyone to the Farmers Market Fall Festival.

Councilman Schindelar stated that the Lake Hopatcong Water Management Plan was discussed recently with the DEP and he encouraged everyone to voice their opinions during this open comment period.

Councilman Padula stated that there are two ordinances on this evening regarding the water and sewer utilities. They are updating the Borough codes. He also reported that the December Land Use meeting will be for discussion regarding the Redevelopment of the River Styx area. In the meantime, the Redevelopment Committee will be meeting with the individual property owners in the affected area to illicit their feedback.

Mayor Petillo suggested that someone from the Council should write a letter to the DEP regarding their lake proposal. This is the first time that the DEP has actually elicited suggestions from the public for a pilot program. Perhaps doing a resolution of support could be the first step.

Mayor Petillo also reminded everyone of the Apple Pie and Art event which will be held this weekend at the high school from 11am to 4pm. She also reminded everyone of the drive thru flu clinic. The clinic will be used as a test to see how well we would do in case we had to mass inoculate our citizens in case of an emergency situation. It is an operational test on preparedness.

Mayor Petillo reported that the 9/11 ceremony went very well and that the Free Little Library was unveiled. The library will contain books regarding 9/11 for people to enjoy while they are sitting at the park.
