# MINUTES OF THE MAYOR AND COUNCIL MEETING, BOROUGH OF HOPATCONG, HELD AT THE MUNICIPAL BUILDING, 111 RIVER STYX ROAD HOPATCONG, NEW JERSEY JUNE 20, 2018 OPEN PUBLIC MEETING 7:30 PM

CALL TO ORDER: Announce Quorum

**OPEN PUBLIC MEETINGS ACT STATEMENT:** <u>Mayor Francis</u> stated "This meeting is held in accordance with the 1975 Open Public Meetings Act, NJSA 10:4-6 et seq., annual notice having been forwarded to the New Jersey Herald/New Jersey Sunday Herald, and posted on the bulletin board maintained in the Municipal Building for public announcements." (Mayor noted fire exits)

**ROLL CALL:** The Clerk called the roll and the following members were present: Councilman Bunce, Councilman Hoferkamp, Councilman Schindelar, Councilman Young and Mayor Francis.

**MOMENT OF SILENT REFLECTION AND PLEDGE OF ALLEGIANCE:** <u>Mayor Francis</u> invited all present to salute the flag and to remain standing for a moment of silence.

**COMMITTEE REPORTS:** <u>Mayor Francis</u> allowed each member of the Council, to present their respective committee reports.

Councilman Hoferkamp reported that the Senior Picnic would be this weekend at the Senior Pavilion and 150+ people were expected. The Lake Hopatcong Yacht Club would be having their Antique Boat Show from 10:00am to 3:30pm this Saturday as well; there would be a parade of boats going by the bandstand. On June 26, 2018 Seniors Inc. would be having their installation of officers at the Elks Club at noon. On June 29, 2018 the Lake Hopatcong Yacht Club would be having a fireworks display at 9:30pm.

Councilman Young reported that the Municipal Alliance would be hosting three outdoor movie nights on July 7, July 21, and August 4; the movies would be *Inside Out*, *Justice League*, and the *Greatest Showman*. He mentioned that the high school held a bike rodeo which emphasizes bike safety for children under 12 and the Alliance will be trying to attach an antidrug message to it next spring. The Hero Boy/Girls on the Run are done for this year and they are planning next year. The Alliance has sponsored Project Graduation and it is almost here; they have done fund raisers all year long and it may not cost the seniors anything this year. Councilman Young reported that the clothing bin will be at the Senior Center soon; they met with the Hopatcong Garden Club to discuss the area. They had a discussion regarding the every 15 minutes program and emergency services with the school system. The Alliance will be at the Farmers Market this which is community service program day.

Councilman Young reported that at the Recreation Commission meeting they reviewed the Memorial Day Parade which went well. They discussed the Hopatcong Days Parade which was coming up; the routes have been changed and will now be from Hudson Maxim to Modick Park. There will be a bike decorating contest and adults can decorate their cars. The three volunteer groups, (soccer, Little League, and the Hopatcong Warriors) will be sponsoring things for Hopatcong Days. The Summer Rec program will be starting July 2, 2018 and so far 150 campers have signed up; enrollment is higher this year.

Mayor Francis reported that on the opening day for the Hopatcong Farmers Market there was a good turnout; there were a lot of vendors there and the Fire Department came to the Market as well. Mayor Francis reported that the Mayors Pride community work program was working well and that some of the workers were working with the DPW during the week.

David Harris questioned the Capital Ordinance regarding Water/Sewer utilities and questioned if the amount was yearly.

Mayor Francis explained that Capital Ordinances change from year to year and that this would be going towards equipment and vehicles.

Mr. Harris questioned the agenda and how many liquor licenses were being renewed.

Mr. Ursin informed him that eight licenses were being renewed and gave him the resolution.

Mr. Harris questioned the street paving list.

Mayor Francis stated the streets that were on the list to be paved and informed him that we have received grant money to pave Flora and Durban.

Lynn Owens-14 Papoose Trail thanked the Mayor and Council for their efforts with the road paving and questioned if there is anything the residents should do for the road paving.

Councilman Bunce asked them to move anything that they have on the road, such as vehicles.

Ms. Owens questioned a property a of couple houses down from her that is empty.

Mayor Francis explained that the property is 22 Papoose Trail and that he spoke to the Zoning Officer in regards to it. He will be issuing the necessary notices.

Mara Modes questioned what the Sustainable Land Use Pledge was.

Mayor Francis explained that it is for our Environmental Commission and is a part of Sustainable New Jersey and helps us to receive certifications.

Mr. Harris commented that there was a nice article in the NJ Herald regarding the solar panels. Mr. Harris commended the Recreation list posted in the Municipal Building and commented that there were still cracks in the skate park. Councilman Young commented that the facility is active right now and they have to wait until the spring activities are finished since they would have to shut down the park.

Mara Modes shared her concern regarding the police and monitoring the kids hanging off the tailgates of the pickup trucks by the beach clubs.
